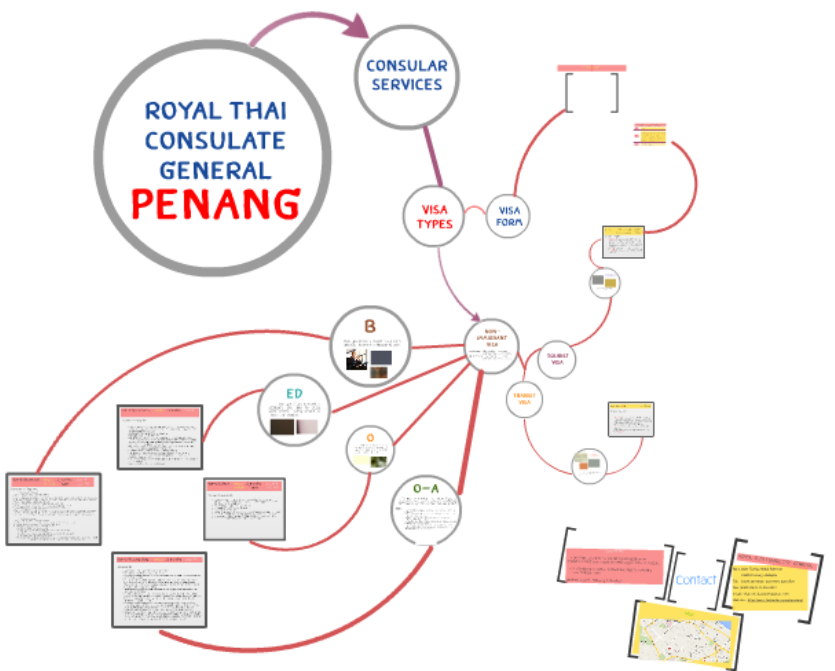

This type of visa for those who will transit to a third country or wish to participate in sports activities in Thailand

Transit Visa : 90 RM

for 30 days

Document Required:

- **Passport** or travel document with validity not less than 6 months of remaining validity and blank visa pages, and a photocopy of the passport's data page and the photo page if it is separate.
- Visa application form completely filled out
- **2 photos** (2 inch, color, front-view, taken within 6 months)
- Fully-paid confirmed roundtrip air ticket and copy
- Fees **90 RM**.

NON- IMMIGRANT VISA

Single entry – Visa validity : 90 days
Permit to stay : 90 days stay
multiple entry – Visa validity : 1 year
Permit to stay : 90 days stay

This type of visa is issued to applicants who wish to enter the Kingdom to work.

Documents Required:

- For employment purposes

1. Copy of passport and two recent photographs
2. Copy of academic degree(s) or curriculum vitae
3. Original letter of recommendation of the company/employer stating the reason for employment, position and salary.
4. Copy of the company's registration certified by authorized director(s), if teaching-school registration duly certified.
5. Copy of list of company's shareholders (if any)
6. Copy of Memorandum of Association/company's Regulation (if any)
7. Copy of the company's latest income tax statement (Por.Ngor.Dor50 and 30)
8. Copy of the company's latest regulation of value added tax (Por.Ngor 20)
9. Copy of the company's latest balance-sheet
10. List of expatriates and foreign workers employed by the company (specified by name, nationality and position)
11. In case of exporting company, bill of lading or bank statement(s) indicating exporting transactions is required.
12. Original Copy of the 'Applicant Receiving Form' WP.3 from the Department of Employment- a must or work permit.

- For Business purposes

1. Copy of passport and two recent photographs
2. Letter of recommendation of the applicant's company indicating the reason of visit
3. If self-employed, please present financial state of the applicant
4. Documents required from the inviting company in Thailand
 - 4.1 Letter of invitation stating reason of visit
 - 4.2 Copy of the company's Registration certified by authorized director(s)
 - 4.3 Copy of list of company's Shareholder(s)
 - 4.4 Copy of the company's latest registration of value added tax (Por.Nor.20)
 - 4.5 Copy of the company's latest balance-sheet
- Original Copy of the 'Applicant Receiving Form' WP.3 from the Department of Employment- a must or work permit.
[for Multiple entries: Original Work-permit must be produce with the application]

ED

This type of visa is issued to applicants who wish to study, attend seminar, training session, or internship in Thailand.



Non-ED (Education) : single : 3 months 220 RM.

Documents Required:

- Passport or travel document with validity not less than 6 months of remaining validity and blank visa pages, and a photocopy of the passport's data page and the photo page if it is separate.
- Two recent photographs of applicant (4x6 cm)
- Visa application form completely filled out
- For those wishing to study in a Private institution, an official letter from the Ministry of Education of Thailand, or other sub-authorities concerned, approving the enrolment of foreign students and a copy of registration certificate of the concerned academic institute are required
- Transcript/ class schedule /Letter of acceptance from the concerned schools/ universities or institutes qualified to enroll foreigners
- Academic record and the Student ID (if currently studying)
- For those wishing to attend seminar, or training session, or internship, a recommendation letter from the concerned organisation addressed to the Consulate is also required
- Letter from Ministry of Foreign Affairs (only for the applicant who wish to study in A.I.T University)
- Original receipt of tuition fee and its copy

This type of visa is issued to applicants who wish to accompany spouse or family members working, studying or living in Thailand.

Documents Required:

- Passport or travel document with validity not less than 6 months of remaining validity and blank visa pages, and a photocopy of the passport's data page and the photo page if it is separate.
- Two recent photographs of applicant (4x6 cm)
- Visa application form completely filled out
- Copy of marriage certificate
- Certified Copy of spouse's ID card (for spouse of Thai nationals) and duly signed
- Copy of house registration book (for spouse of Thai nationals) and duly signed
- Other relevant document, for example, copy of child's birth certificate / ID card
- A copy of bank statement showing a deposit of the amount

O-A

This type of visa may be issued to applicants aged 50 years and over who wish to stay in Thailand for a period of not exceeding 1 year without the intention of working. Holder of this type of visa is allowed to stay in Thailand for 1 year. Employment of any kind is strictly prohibited.

Eligibility :

- Applicant must be aged 50 years and over (on the day of submitting application).
- Applicant not prohibited from entering the Kingdom as provided by the Immigration Act B.E. 2522 (1979).
- Having no criminal record in Thailand and the country of the applicant's nationality or residence.
- Having the nationality of or permanent residence in the country where applicant's application is submitted.
- Not having prohibitive diseases (e.g., Leprosy, Tuberculosis, drug addiction, Elephantiasis, third phase of Syphilis) as indicated in the Ministerial Regulation No. 14 B.E. 2535.



Non-OA (Long Stay) : **single** : 3 months 220 RM.

Documents

- Passport with validity of not less than 18 months.
- 3 copies of completed visa application forms.
- 3 passport-sized photos (4 x 6 cm) of the applicant taken within the past six months.
- A personal data form.
- A copy of bank statement showing a deposit of the amount equal to and not less than 800,000 Baht or an income certificate (an original copy) or property deed. The applicants need to prove or demonstrate adequate income documents or assets to support their living in the country.
- In the case of submitting a bank statement, a letter of guarantee from the bank (an original copy) is required.
- A letter of verification issued from the country of his or her nationality or residence stating that the applicant has no criminal record (verification shall be valid for not more than three months and should be notarised by notary organs or the applicant's diplomatic or consular mission).
- A medical certificate issued from the country where the application is submitted, showing no prohibitive diseases as indicated in the Ministerial Regulation No.14 (B.E. 2535) (certificate shall be valid for not more than three months and should be notarised by notary organs or the applicant's diplomatic or consular mission).
- In the case where the accompanying spouse is not eligible to apply for the Category 'O-A' (Long Stay) visa, he or she will be considered for temporary stay under Category 'O' visa. A marriage certificate must be provided as evidence and should be notarised by notary organs or by the applicant's diplomatic or consular mission.
