The Royal Thai Embassy, Warsaw, in partnership with the Team Thailand in Warsaw, is scheduled to organise "Thai Festival 2024" on Sunday 8 September 2024 from 10:00 - 17:00 hrs. at Targ Śniadaniowy – Mokotów, Warsaw. The event aims to promote Thailand in various fields to promote the country's image and raise the awareness on Thailand among the Polish public, focusing on trade, investment, and tourism. The festival will feature Thai art and cultural performances, a Muay Thai competition, booths selling Thai products, food, and drinks, and booths for Thai massage, as well as information on tourism in Thailand. Activities for children and youth will also be arranged.

In this regard, the Royal Thai Embassy is pleased to invite entrepreneurs who are interested in participating in the Thai Festival 2024 event to set up booths for selling or displaying Thai food and/or products. All the food and products in the event <u>must be exclusively related to Thailand.</u> Entrepreneurs will be selected based on the information provided in this application form. The Royal Thai Embassy, Warsaw will select businesses and products which align with the objectives of the event, considering the variety and appropriateness of in promoting Thailand in Poland

2. Fees and Security Deposits

- 2.1 The Royal Thai Embassy will cover the expenses for venue set up as follows:
 - (1) rental of the booth (approximately 2 x 2 meters)
 - (2) rental of 2 3 tables and 2 chairs (inside the booth)
- (3) Booth installation and dismantling costs, electricity (up to 3 kW), waste disposal fees (garbage bags not included) and other expenses necessary for proper management in compliance with relevant Polish regulations.

(4) Booth signage production fee

- 2.2 The entrepreneurs are obliged to pay security deposit of <u>500 PLN</u>, which will be refunded after the event, with the following conditions:
- (1) If there are damages or fines imposed by Targ Śniadaniowy or relevant Polish authorities due to the actions of participating entrepreneurs (e.g., improper garbage disposal, parking in prohibited areas, oil stains from cooking, or damage to booths/tents), the responsible entrepreneur's deposit will be deducted to cover such damages or fines. If such damages or fines exceed the security deposit amount, the responsible entrepreneur must be responsible for the said additional costs.
- (2) If damages to the event venue cannot be attributed to a specific entrepreneur or multiple entrepreneurs, security deposit of each entrepreneur shall be deducted equally to cover such damages or penalties.
- (3) Any remaining deposits left from the above-mentioned deduction in point (1) and/or point (2), will be refunded to participating entrepreneurs within 30 days after the event's completion. Should the compensation required for damages or fines exceed the deposit amount, additional fees shall be collected from participating entrepreneur/entrepreneurs to cover the excess costs.

3. Registration and Selection Process

The completed registration form should be submitted to the Royal Thai Embassy via email at <u>contact@thaiemb.pl</u> between 24 July - 2 August 2024. The Royal Thai Embassy will select entrepreneurs based on the qualification detailed in this form, and results will be announced via email by 5 August 2024.

Please note that while submissions will be reviewed on a first come, first served basis, other relevant details will also be considered in the selection process.

4. Term of Payment

The selected entrepreneurs must pay the full amount of security deposit, as outlined in Section 2.2, in cash at the Royal Thai Embassy by 13 August 2024, during the embassy's working hours.

*** Regulations, Terms, and Conditions ***

Selected entrepreneur/entrepreneurs who fails/fail to pay the security deposits by the date as specified in Item 4, will be immediately disqualified.

Entrepreneurs who have been selected and have paid the security deposits but are unable to participate in the event, should submit a written notification to the Royal Thai Embassy, Warsaw by 27 August 2024. They will receive half of the security deposit (250 PLN) back. However, for those who are unable to attend the event and do not notify the Embassy in writing by the specified date, their deposits will be forfeited.

Selected entrepreneurs, who wish to sell alcoholic beverages in the event, are responsible for obtaining the license to sell alcoholic beverages by themselves, and must strictly adhere to all relevant regulations. The Royal Thai Embassy will not be responsible for any fines and closures as imposed by local authorities, as well as damages caused by weather conditions, natural disasters, or other unexpected events. In addition, under no circumstances will the Royal Thai Embassy be obliged to make good or accept any responsibility or liability whatsoever arising in respect to claims against products and services sold at this event.
