**Announcement**  
**New Procedure for Submitting Thai Visa Application for Sudanese Citizens**  
**From 1 May 2022 onwards**

In order to facilitate a Sudanese traveler wishing to visit Thailand from Sudan, the Royal Thai Embassy in Cairo, by the instruction and authorization from the Ministry of Foreign Affairs of Thailand, hereby announces the new procedure for submitting Thai visa application for Sudanese citizens, as follows:

**1. Visa Application:**

The applicants can now choose to apply for visa either directly in person with the Royal Thai Embassy in Cairo or through the visa processing service companies in Khartoum or a representative.

**2. Visa Processing Service Companies:**

2.1 The visa processing service companies or a representative must have **a written approval** from the applicants to submit a complete visa application form together with the required documents to the Royal Thai Embassy on behalf of the applicants.

2.2 The visa processing service companies or a representative shall be responsible for pre-screening of the visa applications and all required documents for each visa category in accordance with the Guidelines/Instructions provided by the Royal Thai Embassy. These Guidelines/Instructions can be found on the official website of the Royal Thai Embassy at <https://cairo.thaiembassy.org/en/>.

2.3 The visa processing service companies or a representative shall be responsible for the payment of visa fees as required for each visa category on behalf of the applicants, and it should be pay only **in cash** and **in Egyptian pounds (EGP)** at the Royal Thai Embassy in Cairo.

**3. Recommended Companies:**

3.2 The Royal Thai Embassy in Cairo reserves the right to suspend and terminate any visa processing companies without prior notice and/or providing any reasons.

#### 4. Delivery Process:

4.1 All applications together with passports and required documents shall be delivered directly to the Royal Thai Embassy in Cairo by **a representative who has a written approval from the applicants or the visa processing service companies**. The Royal Thai Embassy will not accept any application through a courier.

4.2 Passports with visas will be returned to the same authorized representative as mentioned in 4.1 once it has been issued by the Royal Thai Embassy in Cairo.

#### 5. Visa Fees:

5.1 Transit Visa	600 EGP
5.2 Tourist Visa (Single Entry)	700 EGP
5.3 Non-Immigrant Visa (Single Entry)	1,300 EGP

#### 6. Additional Documents If Requested:

If additional documents are requested by the Royal Thai Embassy in Cairo, the applicants may be able to submit them via email: [consular.cai@mfa.go.th](mailto:consular.cai@mfa.go.th) (on case-by-case basis)

#### 7. Visa Process:

It takes approximately 3 working days for issuing of visa after receiving a complete application and all required documents.

In addition, any Sudanese who are residents of Sudan are advised to submit their visa applications **at least six weeks** before the date of departure to Thailand in order to avoid any unforeseen circumstances.

**Remark:** This announcement is subject to change if there is an update on the visa procedure as instructed and authorized by the Ministry of Foreign Affairs of Thailand.
