

Announcement by the Royal Thai Embassy, Cairo Subject: Disposal of Used Property by Public Auction # 2

The Royal Thai Embassy in Cairo hereby announces its intention to sell a used government vehicle by conducting a public auction through **written bidding**. The details are as follows

- 1. A Toyota Land Cruiser Prado, year 2016, engine capacity 2700 cc, 7 seats, white color, purchased on 29 June B.E.2559 (A.D.2016) (Details attached to this announcement)
- 2. Mileage 156,500 kilometers
- 3. The minimum price set is 1,250,000 Egyptian Pounds, or equivalent to 26,460.-US Dollars.
- 4. Auction period: From 21 December 2025 to 5 January 2026. Bidders must submit their bidding price in a sealed envelope to the Embassy within this period. Attention: Finance Officer.
- 5. Auction venue: The Royal Thai Embassy, Cairo. Tel. 3760-3553/4 Ext. 113
- 6. The said vehicle is sold in its present condition. Bidders should read the auction announcement and inspect the vehicle by themselves before participating in the auction. Once agreeing to participate in the auction, it shall be deemed that the bidder has acknowledged and accepted all conditions and details of this auction. The bidder may not claim or request the Royal Thai Embassy to undertake any action to improve, modify, or alter the auctioned vehicle to be in better condition.
- 7. The bidder shall offer a price not lower than the price set by the Royal Thai Embassy, and the bidder who offers the highest price shall obtain the right to purchase the said vehicle. The bidder shall make full payment or place a deposit of not less than 20 percent of the bid price, immediately at the Finance Section of the Royal Thai Embassy together with proof of identity. The Royal Thai Embassy shall issue an official receipt as evidence. The bidder shall pay the remaining amount in full within 15 working days from the auction date and shall contact the Royal Thai Embassy to collect the said vehicle within 5 working days from the date the full payment is completed.

/ 8. The buyer shall be responsible...

- 8. The buyer shall be responsible for all expenses relating to the transfer of registration or ownership, the fee for changing the license plate, transportation costs, taxes, and any other related expenses.
- 9. If the bidder does not complete the payment within the specified date, it shall be deemed as a forfeiture of the right, and no claims for damages or any expenses may be made.
- 10. The bidder must not have any shared interests with other bidders and must not engage in any act that obstructs fair competition in this bidding process.
- 11. Members of the committee responsible for this vehicle auction shall not have the right to submit a bid.
- 12. Interested people who wish to participate in the auction of the said vehicle may contact the Royal Thai Embassy for further information during official working hours from 21 December 2025 to 5 January 2026 at 16.30 hrs.
