1) Green Factories to Get Priority for Industrial Zones

Cost-effective and low-pollution factories will be given priority in awarding licenses for operations at new industrial zones in Myanmar, said Vice President U Nyan Tun at a coordination meeting on industrial zones in Yangon region. Yangon region currently has 29 industrial parks.

U Aung Myint, Union Minister for Industry, held a meeting with Mr Chalermphol Assakul, Director of Bangkok Weaving Mills Limited, Thailand and party on 22 August 2014 in Nay Pyi Taw. They discussed making investment in Myanmar's garment industry. U Aung Myint said that the Ministry will hire No.3 garment industry (Sagaing) and its staffs to the private company.

3) Myanmar to formally introduce E-visa for Foreign Tourists

Myanmar's immigration authorities will formally introduce online electronic (e)-visa for all foreign tourists from 1<sup>st</sup> September 2014 according the ministry's website. It will take five days to get the e-visa. Tourist arrivals in Myanmar shot up from 1.06 million 2012 to 2.04 million in 2013.

4) Russia and Myanmar Sign USD 38 million Deal on Oil Survey Wells

Bashneft International BV, a subsidiary of Russia's largest oil products producer-Bashneft, has signed Production Sharing Contract (PSC) with Myanmar Oil and Gas Enterprise (MOGE) for the distribution of the Block EP-4 oil well which is 841 sq kilometers located in the central Myanmar. Investments in the program will be USD 38.3 million and signing bonus totals USD 4 million, said Bashneft.

5) IP Laws drafted, to be submitted to Parliament soon

Intellectual property right bills have been drafted and will be submitted to the parliament soon said U Ba Shwe, Deputy Minister for Science and Technology. The ministry also set MoU with Korea's Intellectual Property Office and is also working with United States Patent and Trademark Office (USPTO) and European Union's Office for Harmonization of Internal Market.

6) Capital Development Company to build Myaenigone flyover

Capital Development Company, a local construction firm, has won the tender to build 650 meters long and 14.5 meters wide, Myaenigone overpass in Yangon which is aimed to reduce traffic jams in the city. Yangon Region government proposed to spend USD 17 million on the construction of the flyover in 2014-2015 FY.

7) Tourist arrivals almost double at Nay Pyi Taw Airport

Tourist arrival to Nay Pyi Taw in the first seven month of this year has almost doubled to that of the same period last year, according to the Ministry of Hotels and Tourism. A total of 10,621 foreign tourists had arrived in Nay Pyi Taw International Airport between January-July 2014, up from 5,428 during the same period last year.

8) Highway linking India to Myanmar, Thailand likely to finish by 2016

Two major connectivity projects-Kaladan Multi-modal Transit and India-Myanmar-Thailand trilateral highway-are likely to be completed by 2016, said VK Singh, India's Minister for External Affairs. Kaladan project will connect Kolkata to Sittwe port in Myanmar and further to Mozoram by river and road. The trilateral highway will run from Moreh in Manipur to Mae Sot in Thailand via Myanmar.

9) China Union Pay International Card to be introduce in Myanmar next month

China Union pay International (UPI), in cooperation with Myanmar's cooperative Bank (CB), will introduce EASi Travel Union Pay Card, deposited with Myanmar Kyat, in Myanmar from 1<sup>st</sup> September 2014. China UPI card is being issued in more than 30 countries including Myanmar.

10) JTJB opens in Yangon

12) Muse Central Economic zone to be completed in 2017
