



Announcement of the Royal Thai Embassy
Subject : Sale of Used Items

The Royal Thai Embassy in Yangon wishes to sell 30 used items, as per the enclosed list, with the following conditions:

1. The sale will be conducted by bidding, verbally or in writing. Interested bidders are required to inform verbally, or to submit in writing, his/her bidding price to the Committee before the deadline.

2. The above-mentioned used items will be sold by the Embassy in its actual condition as seen on the date of bidding. Bidders shall not demand or request the Embassy to undertake any alteration to improve the condition of the items.

3. The winning bidder shall make a down payment of 10% of the bidding price within 1 working day at the Finance Section of the Embassy, and shall make payment in full within 7 working days. The winning bidder may collect the item at the Procurement Section within 5 working days after the payment has been made.

4. Any interested bidders who wish to take part in the bidding are required to contact the Procurement Section of the Embassy, located at 94 Pyay Road, Dagon Township, Yangon, Myanmar, from 24 February to 15 March 2016 during office hours (09.00 – 17.00 hrs.) Tel. 222 784 or 226 721 ext 116.

5. The date of bidding is 16 March 2016, and the bidding will take place between 10.00-16.30 hrs. at the Procurement Section of the Embassy.

6. The Embassy reserves all rights to revoke the sale or the bidding of the used item in case that the highest bidding price is not satisfactory. In such case, bidders shall not claim any compensation for damage or any costs which may have been incurred.
