



Announcement of the Royal Thai Embassy, Maputo
Subject: Sale of Embassy Vehicle by Written Bid

The Royal Thai Embassy in Maputo hereby announces its intention to sell a used government vehicle through a public auction by written bidding, with details as follows:

1. Vehicle Information

- Model: Range Rover (SDV6) HSE
- Year of Registration: 2016
- Colour: Bronze
- Engine Capacity: 3,000 CC
- Mileage: ~ 56,000 km
- Registration Number: CD088 M01
- Minimum Sale Price: 2,000,000 Metical

2. Conditions of Sale

2.1 The vehicle shall be sold on an "as is, where is" basis. Interested bidders are advised to inspect the vehicle prior to submitting a bid.

2.2 The vehicle may be inspected at the Royal Thai Embassy in Maputo, Avenida Julius Nyerere No. 4317, Sommershield II, Maputo, Mozambique, during office hours from **24 August to 27 August 2026, between 09.30 a.m. and 03.30 p.m.**

2.3 Interested persons shall submit a sealed written bid indicating:

- Email address
- Offered purchase price

2.4 The sealed envelope shall be clearly marked:

3. Submission Deadline

All bids must be received no later than 28 August 2026 at 2 p.m.

4. Selection of Successful Bidder

4.1 The vehicle shall be awarded to the highest bidder whose offer is equal to or higher than the minimum sale price established by the Embassy.

4.2 The Embassy reserves the right to reject any or all bids without providing reasons.

4.3 In the event that two or more bidders submit the same highest bid, the Embassy may invite the concerned bidders to submit a new bid or determine the successful bidder by an appropriate method.

5. Payment and Transfer of Ownership

5.1 The successful bidder shall make full payment within two (2) working days from the date of notification by transferring to the Royal Thai Embassy Account.

5.2 Failure to complete payment within the prescribed period shall result in cancellation of the award, and the Embassy reserves the right to offer the vehicle to the next highest bidder.

5.3 All costs, fees, taxes, duties, and procedures associated with the registration and transfer of ownership of the vehicle shall be borne solely by the successful bidder. In particular, where the successful bidder is not entitled to diplomatic privileges or tax exemptions, including in the case of a private individual or other non-privileged purchaser, the bidder shall be fully responsible for any applicable taxes, duties, registration fees, transfer fees, insurance costs, and any other expenses required by the relevant Mozambican authorities for the lawful transfer and registration of the vehicle. The Embassy shall bear no responsibility for any such taxes, fees, duties, or other costs arising from the transfer of ownership.

5.4 The vehicle shall be released only after full payment has been received and ownership transfer arrangements have been completed.
