1. Course Title:

Potential Development of Public Health Professionals in Primary Health Systems

2. Duration:

4 weeks

3. Background:

Public health can be defined as the art and science of preventing disease, prolonging life, and promoting health through the organized efforts of society, and includes activities encompassing all organized efforts to promote, protect and improve, and when necessary, restore the health of individuals, specific groups, or populations. Public health professionals work in many places and in many areas of public health mainly focus on population-based services and include surveillance and analysis of the population's well-being, including health status and determinants; health protection and the control of risk factors and diseases; prevention of diseases, injuries, and social problems; promotion of health and well-being; the development and implementation of regulations, legislation and public policies that have an impact on health; research and innovation.

The social and health environment is changing rapidly and impacting health determinants eventually. The strong primary health systems can be the first line of defense to maintain the safety and health of people. Therefore, primary health care and public health professional need to improve to strengthen the public health and preparedness capacity of the local public health professionals. Training that is competency-based helps to ensure that public health professionals are building the knowledge and skills needed for solving those health changes.
