The Third Country Training Program on "Workshop on Investment Promotion Policy and Enhancing Industrial Competitiveness for Mekong and South Asian Countries" is conducted by the Government of Thailand and the Government of Japan as part of their Technical Cooperation Scheme.

The course arrangements are set up by Thailand International Cooperation Agency (TICA), Ministry of Foreign Affairs, and Japan International Cooperation Agency (JICA) in collaboration with Thailand Board of Investment (BOI), Office of the Prime Minister.

Background

With the realization of the ASEAN Economic Community (AEC) in 2015, the promotion of Foreign Direct Investment (FDI) is one of the most prioritized challenges of the Mekong countries in order to maintain sustainable economic growth in light of strong competition. Mitigating the development gap among ASEAN member states is also an important obligation of Thailand. Having achieved remarkable economic growth through the successful implementation of an FDI promotion policy, Thailand is the best resource country to contribute in this regard.

During the Japanese fiscal years 2017-2019, JICA, TICA, and BOI successfully organized two workshops on investment promotion for Mekong countries (CLMV). The workshops received a great deal of interests from government organizations of the CLMV. As the Thai investment in South Asian region has been rapidly increasing over the past few years, BOI would like to include the South Asian Countries in this course. Besides, BOI has also received requests from these countries to organize an investment promotion training program so that they can learn about the Investment Promotion Agency's roles in promoting and facilitating manufacturing FDI, as well as the linkage formation with local supporting industries. In addition, they will be able to explore possible policies and measures to be reflected in their IPA.

As a result, JICA, TICA and BOI agreed to organize two more workshops in order to continue to contribute to the economic and industrial promotion and the development in the Mekong countries.

Qualifications

The participants are requested to have the following requirements;

- (1) be nominated by their governments in accordance with the application procedures;
- (2) have completed at least a Bachelor's Degree or possess an equivalent academic background or in a related field.
- (3) be a government officer working in the promotion of FDI with at least five (5) years of work experience in the government institutions.

- (4) be continuously working in the above-mentioned field after returning to their home countries;
- (5) be under 50 years of age;
- (6) be proficient in spoken and written English and able to contribute effectively to classroom discussion;
- (7) be in good health, both physically and mentally; each participant should have a health certificate provided by an authorized physician, the medical report form is also attached together with the Nomination form. Pregnancy is regarded as a disqualifying condition for participation in the course;
- (8) not be serving in any form of military service; and
- (9) have not previously participated in this workshop.

(2) The Government of the Kingdom of Thailand will inform the applying Government through its diplomatic channels whether or not the applicant(s) is/are accepted in the Course not later than thirty (30) days before the commencement of the Course.

Certificate

Participants who have successfully completed the course will be awarded a certificate by JICA, TICA, and BOI.

Allowance and Expenses

The following allowance and expenses will be borne by the Royal Thai Government and the Government of Japan

- An economy class round trip air ticket between the nearest International Airport of participants' countries and Bangkok will be issued by TICA to the approved candidate.
 - The approved candidates are requested to send a photocopy of his/her passport, the page which shows the correct names for arranging the electronic air ticket.
 - The electronic air ticket will be sent to the approved candidates via email from TICA.

- 2) Living allowance at the rate of Baht 600 per day (equilvalent to approximately US\$17) will be paid to the participant during stay in Thailand. This living allowance is for food and other personal daily expenses. However, each participant is suggested to have a pocket money for a few day expenses prior to the allowance payment.
- 3) In accordance with relevant regulations, free minor medical treatment will be provided for participants who become ill during their stay in Thailand.

- 1) Participants are required to arrive in Thailand on the date as designated by TICA after confirmation of acceptance. However, it will be finally confirmed to the air tickets sent to the participants. The final confirmation of the air tickets will be sent to the participants in advance.
