Updates on the Visa Exemption and Visa on Arrival (VoA)
The Royal Thai Government promotes tourism and economy with
a 60-day Visa Exemption Scheme for listed countries below.
Starting from 15 July 2024 onwards.

Visa Exemption (60 Days)

Nationals of the <u>following 93 countries and territories</u> are entitled to visa exemption for the purpose of tourism, business engagements, urgent or ad-hoc work, <u>for up to a 60-day period of stay and can be extended for another period not exceeding 30 days.</u> Extension of stay is solely at the discretion of the immigration officer. Within the period of stay, traveler can apply for a new type of visa at the Immigration Bureau in Thailand.

Argentina, Chile, Myanmar (International airports only)

For Necessary or Urgent Work or Ad-hoc Work need to notify the registrar in person at any international airport or labour offices in Thailand. The process takes one working day and can only be obtained after the foreigner has entered Thailand. The work shall be completed within 15 days.

16 Types of Necessary or Urgent Work or Ad-hoc Work:

- Organizing or setting up conferences, trainings, seminars, exhibitions, or trade fairs
- 2. Conducting special academic lectures
- 3. Aviation superintendent
- 4. Occasional internet audit
- 5. Follow-up and resolve technical issues
- Quality control of products/goods or products/goods quality inspection
- 7. Inspection or improvement of production process
- 8. Machinery and electric generator equipment system inspection or maintenance

- 9. Machinery maintenance and installation
- 10. Electric train technician
- 11. Aircraft or aircraft equipment system technician
- 12. Consulting work on machinery maintenance or machinery control system
- 13. Machinery demonstration and testing
- 14. Movie filming and slide photographing
- **15.** Recruitment of job seeker for overseas job placement
- **16.** Technical skill testing for overseas job placement

Nationals of the following <u>31 countries and territories</u> may apply for visa on arrival <u>at</u> <u>the immigration checkpoints</u> on arrival for tourism purpose, for a single entry with a period of stay not exceeding 15 days.
