



### Announcement

#### Subject: E-visa registration open for KVK-registered visa handling service agents based in the Netherlands

---

The Royal Thai Embassy, The Hague, will be launching a new online web-based visa system (**e-visa**) by the end of November 2021. With the system activated, all visa applicants can apply for their visas entirely online from step one to receiving an e-visa in a form of PDF file via email. Payment for visa processing fee is also made online in the application process. Consequently, applicants are no longer required to physically visit the Embassy unless invited by the Embassy on a case by case basis.

In order to apply for a visa through e-visa system, an applicant must create an online account in the system which can be used to submit up to 5 applications at a time. This is designed to accommodate small family/group applicants. For visa handling service providers, an account for a visa handling service provider (**agent account**) can be created and used to submit up to 100 visa applications at a time. Approval from the Embassy is required to create the agent account.

In this connection, the Embassy would like to invite interested visa handling service providers who meet the requirements set forth in **Annex A** of this announcement to submit their application for approval to create an agent account by completing the form (**Annex B**) and submit it together with the required supporting document(s) listed therein to the Embassy's email: **consular@thaiembassy.nl**. Approved applicants will be notified and provided with further details.
