

## Requirements for importation of Dogs/Cats/Rabbits into Thailand through port of Suvarnabhumi Airport

1. An applicant who planning to travel with a pet to Thailand or who wants to import pet by air cargo need to obtain an import Permit before their departure by submitting an email request to email: qsap\_bkk@dld.go.th with the following documents within 60 days but not less than 7 day prior to departure date.
  - 1.1 R1/1 form
  - 1.2 Copy of passenger's passport (or copy of pick up person's passport if ship by air cargo)
  - 1.3 Pet's photo
  - 1.4 Flight itinerary
  - 1.5 Vaccination record (must be in English)
  - 1.6 Microchip Implant certificated
    - : Animal must be vaccinated at least 21 days prior to departure against these following disease
    - Dog:** Rabies, Distemper, Hepatitis, Parvo and Leptospirosis
    - Cat :** Rabies and Feline Panleukopenia
    - Rabbit :** Rabies

### Remark:

- For Rabies vaccine: Animal were at least 3 months old or 12 weeks or 84 days at time of administered.
- Dog were test for leptospirosis with negative result within 30 days prior to departure.
  - \* Not required for dog which have a valid vaccine for Leptospirosis
- Rabbit were treat for internal parasite at least 7 days prior to departure.

2. A Veterinary Officer at Animal Quarantine Station (AQS) at Suvarnabhumi Airport will review the documents. If additional information is required, the officer will contact you by email. But if the information provided is complete, the Import Permit will be issued. The scanned Import Permit including import requirements will be emailed to the applicant within 3 working days.

>>The permit issuance process will take at least 3 business days. If you do not get any response within the frame time, you may call AQS (Cargo terminal) to follow up your case at +(662) 134 0731 during 08.30 a.m.- 4.00 p.m. local time Monday - Friday.

[Please note: An Import Permit is not an Import License. On arrival, an applicant needs to contact Veterinary Officers at AQS at Suvarnabhumi Airport for the Import License and pay an Import License fee]
3. Upon receipt the import permit by email, an applicant must print it out and contact the AQS in exporting country in order to obtain an Official Health Certificate.
4. Prior to departure, the following documents must be prepared for inspection:
  - Original passenger's passport (or pick up person's passport if ship by air cargo)
  - Original pet passport or vaccination record
  - Original Official Health Certificate with endorsement and stamped from the government
  - A print out of the Import Permit received from Thailand via email
5. Upon arrival at Suvarnabhumi Airport, the animal must accompanied with an original health certificate and other documents (refer to step 4.) and present to the Veterinary Officer at the following appropriate location:
  - >>**For hand carried pet:** AQS (Port of entry) located next to carousel No. 8

  - >>**For pet imported by air cargo:** AQS (Cargo terminal: Free Zone Area, CE-1Building)  
Tel. +(662) 134 0731 Business hours 08.30 a.m.- 4.30 p.m. Monday to FridayA Notice of Import Approval (Form R-6) and Import License (Form R-7) will be issued at this location. A processing fee of 500 baht will be charged per animal and receipt provided.

**Remark:** If the animals do not meet an import requirement or the microchip number in documents not conform with the microchip number which the animal bears, the animal may be returned to exporting country or detained for further appropriate actions in the quarantine place approved by the government. All expenses are to be borne by an importer.
