No.	Documents require for Non-Immigration Visa - Other/Thai Spouse	Yes
1	An Application form and A Declaration form *One (1) typed and signed application form and declaration form with complete and accurate details. *Handwritten application form will not be accepted.	
2	Two (2) photograph of passport size with WHITE BACKGROUND , taken within the past six months.	
3	Original passport and Photocopy of passport *Minimum of 6(six) months validity from the date you start from your journey, with a blank visa page to affix the visa sticker. *Pages showing the applicant's photograph, details, date of issue and expiry.	
4	Photocopy of UAE Residence Visa *Every applicants must have U.A.E. valid residence visa, a minimum of 6(six) months validity . *GCC citizens submit a copy of their valid Emirates ID.	
5	Original Guarantee or No objection letter *Sponsor by company - The company letter issue on a proper Company's letterhead in original, duly stamped and with the name of the signatory (Only english version) *Sponsor by spouse's or parent's visa, Letter from the sponsor, Passport and Residence visa copies also required. *The sponsor name as mentioned on the UAE Residence visa must match with letter. *Investor/Owner/Partner of the company must provide the letter and a valid copy of trade license. *Children below 15 years of the age must provide a No Objection to travel letter signed from father AND mother or official guardian with passport copies and residence visa copies. *Handwritten letters, Electronic letters AND Scanned letters will not be accepted.	
6	Itinerary ticket - Copy of confirmed roundtrip airline reservation *The ticket from the airline must show an outbound trip from Dubai. *Ticket Airline PNR number must be accessible on the airline system. *Agency booking or E-mail bookings with no PNR number will not be accepted.	
7	Copy of confirmed hotel reservation (ASQ - Alternative State Quarantine) * The hotel reservation must start from the date of arrival into Thailand and covering the full trip and the evidence to show a payment with complete detail. * The name of the person (including family members with children or accompanying person names) applying for visa must appear on the hotel reservation. In case where the accommodation is booked under a different name, A letter by typed and signed from the person whose name appears on the booking must be provided along with a copy of his/her passport. * E-mail correspondence without hotel confirmation will not be accepted. 8	Insurance *A valid health insurance policy covering all expenditures of medical treatment all the period time to stay in Thailand, including COVID-19 worth at least 100,000 USD.	
9	In the case - (Thai Spouse) 1) Invitation/Introduction letter from Thai Spouse 2) Copy of Thai Identity card 3) Copy of Thai Passport / Copy of UAE Residence Visa (If any) 4) Copy of Thai house registration 5) Copy of Marriage Certificate	
10	In the case - (Medical Treatment) - The Approval form The Ministry of Health. (Please contact to the Hospital to provide) - The history of a medical report (not more than 3 months) - The appointment from the hospital in Thailand	
11	In the case - (Volunteer Job) An official recommendation letter from organization perform voluntary job in Thailand	
12	Original Bank Statement *Original stamped Bank Statement balance of the personal account for previous consecutive 2 months not less than AED47,000/Bath400,000 - or an income certificate with a monthly salary not less than AED5,000/Bath45,000 (when submitting the bank statement, fresh stamp from the bank verifying the account and balance is to be presented)	
13	Visa Fee: 800 AED for Single Entry / 1,500 AED for Multiple Entries Please bring exact amount of money with you. The consulate does not provide any change.	
14	Validity of a Visa: 3 months (single entry) / 1 Year (multiple entries)	

*** Important**

- a. All documents **MUST BE IN ENGLISH ONLY**
- b. Online visa appointment is compulsory for **EACH** applicant/passport
- c. All applicants must come to the Consulate in person for visa submission except for children below the age of 15 years.
 But Birth certificate/Marriage Certificate also are require in case of submission on behalf of spouse and children
- d. Once the documents are submitted to the consulate, it shall not be returned to the applicant
- e. Copies of documents taken through **phone/ tablets/ Ipad and printed out** will not be accepted.
- f. **The Consulate-General reserves the rights to request for additional documents from each applicant.**
Additional documentation may be requested by the Consulate-General.
- g. Applicants are required to pay a visa fee which is non-refundable, whether the visa is approved or not
- h. All copies above must be attest as "CERTIFIED TRUE COPY" and signed in and sealed by the signatory
