**Announcement**  
**Procedures for Non-Thai nationals who are eligible to apply  
for Certificate of Entry into Thailand by Qatar Airways**

The Civil Aviation Authority of Thailand grants the permission for Qatar Airways to resume their commercial route Doha - Bangkok for (1) Non-Thai Nationals who are eligible to apply for Certificate of Entry into Thailand, and (2) Thai Nationals who will be quarantined in only Alternative State Quarantine.

Royal Thai Embassy in Doha would like to provide information on procedures to apply for the Certificate of Entry into Thailand for Non-Thai Nationals who would like to enter Thailand :

1. The eligible groups of non-Thai nationals who are eligible to apply for Certificate of Entry into Thailand:

**1.1 Members of Diplomatic Missions, Consular Representatives and International Organisations (DCIOs) in Thailand**, including spouse, children and parents;

**1.2 Spouse, Children or Parents of Thai Nationals** holding legal documents to prove the relationship with the Thai National;

**1.3 Holders of Certificate of Residence** or a person who has been permitted to have residency in Thailand, including spouse and children;

**1.4 Holders of a valid Work Permit** or a person who has been granted permission to work in Thailand, including spouse and children;

**1.5 Students in any educational institution under approval of Thai authorities**, including parents or a guardian;

**1.6 Persons in need of medical treatment**, including accompanying person, except for COVID-19 treatment (an applicant must directly contact the hospital in Thailand to apply and request for approval).

**1.7 Holders of a valid Non-Immigrant Visa "O-A" or "O-X"** or a person who would like to apply for this category of Visa.

2. **Eligible persons may make a flight reservation directly with Qatar Airways and subsequently submit required documents 10 days in advance before departure date** such as Flight ticket, Alternative State Quarantine booking confirmation (List of Government-designated ASQ as shown in this link <https://bit.ly/3iBrmJV>), insurance policy covering the treatment of COVID-19 in Thailand with a minimum coverage of USD 100,000, to the Embassy by email : [consular.DOH@mfa.mail.go.th](mailto:consular.DOH@mfa.mail.go.th) to apply for a Certificate of Entry (COE) into Thailand. The Embassy will inform related procedure via email.

3. Prior to the departure, a Fit-to-Fly Health Certificate and a COVID-19 Test Certificate with negative result, which are issued within 72 hours before departure, are required to be presented at Qatar Airways Check-in Counter.
