

Schemes for Entering Thailand (by Air Travel), effective from 1 November 2021

***Fully vaccinated** = those who have received **all required doses** of a vaccine registered with the Thai FDA, or approved by WHO or Thai Ministry of Public Health, **no less than 14 days before departure**. (*Accepted vaccines*: Sinovac, AstraZeneca, Johnson & Johnson, Pfizer, Moderna, Sinopharm, Sputnik, Covaxin). **Unvaccinated children under 12** travelling with vaccinated parent(s) may enter Thailand under the same conditions as their parent(s). **Unvaccinated children from 12 to under 18** travelling with vaccinated parent(s) may enter Thailand under the Sandbox Programmes with their parent(s). **Travellers who have recovered from infection** are eligible if they have received **one dose** of vaccine within 3 months after infection, no less than 14 days before departure, and can provide a medical certificate confirming their infection.

****Eligible Countries/Territory**: Australia, Austria, Bahrain, Belgium, Bhutan, Brunei Darussalam, **Bulgaria**, Cambodia, Canada, Chile, China, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, India, Indonesia, Ireland, Israel, Italy, Japan, Kuwait, Laos, Latvia, Lithuania, Luxembourg, Malaysia, Maldives, Malta, Mongolia, Myanmar, Nepal, Netherlands, New Zealand, Norway, Oman, Philippines, Poland, Portugal, Qatar, **Romania**, Saudi Arabia, Singapore, Slovakia, Slovenia, South Korea, Spain, Sri Lanka, Sweden, Switzerland, UAE, UK, USA, Vietnam, Hong Kong, Taiwan.

*****Exception**: The "21 days" requirement **does not apply** to travellers who reside in Thailand and travel to eligible areas for a **short-term visit**, provided that they have not been outside of these areas before returning to Thailand.

****Sandbox areas include, among others, **Bangkok, Phuket, Krabi, Phang-Nga, Surat Thani** (*Koh Samui, Koh Phangan, Koh Tao*) and **Chonburi** (*certain districts only*). Sandbox travellers must arrive **through international airports** at Suvarnabhumi, Don Mueang, Chiang Mai, Phuket, Samui, U-Tapao or Buriram (chartered flights only). **At present, domestic flight transit to Sandbox areas via Bangkok is only possible for Samui** (through designated flights PG5xxx only. More information: <https://www.bangkokair.com/samuiplus/>).

From 1 November 2021

- **Removal of Quarantine Requirement**

- Travellers from **Bulgaria and Romania** may enter Thailand without quarantine provided that they are **fully vaccinated at least 14 days before travelling** and have been in the eligible areas for at least 21 consecutive days.
- They must have a **fully-paid SHA+ or AQ hotel reservation for at least 1 night, inclusive of one RT-PCR test**.
- They must also have **health insurance in English with a minimum coverage of 50,000 USD** and **negative RT-PCR test result issued within 72 hours before departure**.
- They will have to take an RT-PCR test on the day of arrival and will be allowed to leave the hotel after receiving their negative test result.
- For Phuket, an RT-PCR test can be pre-booked separately via www.thailandpsas.com.

- **New Registration Platform**

- On 1 November 2021, the Certificate of Entry (COE) platform will be discontinued. Those wishing to enter Thailand will have to register via **the new platform, “Thailand Pass”** (<https://tp.consular.go.th>). They must register through the new platform **at least 7 days before departure**. - Instead of COE, travellers will need to show a **QR Code generated through the Thailand Pass system** upon check-in and arrival in Thailand.
- **Those who have already been issued COEs before 1 November 2021 may use their COEs to enter Thailand**. There is no need to register again for Thailand Pass.
