VoA (Visa on Arrival)

- Countries eligible to apply for a Visa on Arrival (VoA) at designated immigration checkpoints
- Fee 2,000 THB
- The criteria are as prescribed by the Immigration Bureau

EU Visa Cascade

- Visa Cascade is not a visa exemption scheme
- Thailand was granted the Visa Cascade regime by the EU on 8 May 2026.
- Thai nationals are required to apply for Schengen visas through the normal process.
- Eligible to obtain longer-validity multiple-entry visas

Effective from 15 September 2026

Status as of 31 August 2026
