**Announcement**  
**on Thai visa application for residents of Bulgaria**

Residents of Bulgaria who wish to apply for a Thai visa shall proceed as follows:

**1. Application for a tourist visa:**

- Applicants must prepare documents as required by the Royal Thai Embassy, Bucharest. The complete list of required documents and application form can be downloaded from the Embassy's website:

**language without an official English translation will not be accepted.**

- Once all the documents are complete, applicants have two options for documents and passports submission:

**(1) Documents and passports submission in person at the Royal Thai Embassy, Bucharest (12 Vasile Conta Street, Sector 2, Bucharest, Romania)**

- Applicants shall send an email to [visa.BUH@mfa.go.th](mailto:visa.BUH@mfa.go.th) to schedule an appointment for documents and passports submission. The Embassy will confirm the appointment date and time by email. **Applicants who come without an appointment will be rejected and they have to make a new appointment.** Visa fee is paid in cash in Euro at the Embassy.



**(2) Documents submission at the Royal Thai Honorary Consulate, Sofia  
(Sofia 1000, Parchevich 42)**

- Applicants can submit their documents and passports at the Honorary Consulate on **Tuesday and Thursday from 10.00 to 14.00 hrs.** Applicants' passports and documents will be sent to the Royal Thai Embassy, Bucharest by courier. Courier fees will be paid in cash in BGN and visa fees will be paid in cash in Euro at the Honorary Consulate.

**2. Application for other types of visa:**

- Applicants shall send an email to obtain lists of required documents from the Embassy at [visa.BUH@mfa.go.th](mailto:visa.BUH@mfa.go.th). In the email, please specify **applicants' full names, type of visa they wish to apply, date of departure, and duration of stay in Thailand.**
- Applicants shall send scanned copies of the required documents and completed application forms to the Embassy by email for verification.
- When the documents are complete and verified, the Embassy will notify applicants by email to arrange an appointment for documents submission either at the Royal Thai Embassy, Bucharest or at the Royal Thai Honorary Consulate in Sofia.

***\*\* The Royal Thai Embassy, Bucharest reserves the right to request additional documents as deemed necessary.***

***\*\*\* Applicants shall be responsible for the information given in the application form as well as the submitted documents. Any false or misleading information, or false supporting documents, may result in the refusal of a visa application without the right of appeal.***



*The Royal Thai Embassy, Bucharest reserves the right to reject visa applications with incomplete/incorrect documents, applicants who have stayed in Thailand for more than 90 days within the last 6 months preceding the date of applying, applicants who overstayed or engaged in visa running and/or other illegal activities.*

*\*\*\*\* The Royal Thai Embassy cannot accommodate urgent requests. The applicants must ensure that they leave sufficient time for their visa application process before their planned departure. It is advised to start the visa application process at least 21 days before departure date. Applications by certain nationals can take up to 3 months for approval.*

**3. Thailand Pass registration:**
