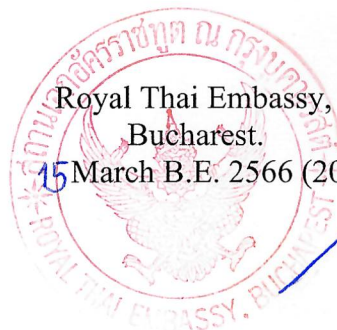
### **Subject: Thai Festival 2023 in Bucharest**

The Royal Thai Embassy, Bucharest, in partnership with the Office of Commercial Affairs in Budapest and the Tourism Authority of Thailand (TAT) Prague Office, will organise Thai Festival 2023 on Saturday and Sunday 20-21 May 2023 at Dimitrie Gusti National Village Museum, Sector 1, Bucharest. The objectives of the Thai Festival 2023 are to promote various aspects of Thailand in Romania such as trade, investment, tourism, Thai culture and tradition, cordial relations between Thailand and Romania and to commemorate the 50<sup>th</sup> Anniversary of the establishment of the diplomatic relations between Thailand and Romania.

The Thai Festival 2023 in Bucharest will consist of booths for Thai food, beverage, Thai products, information booth on Thailand, as well as cultural performances such as traditional Thai dance, music, Muay Thai, performances from a Romanian school, and other activities for children and youths who visit the Thai Festival.

## Application and Selection Process

Interested persons shall submit a fully completed and signed application form to the Royal Thai Embassy, Bucharest to the email [krittidech.w@mfa.go.th](mailto:krittidech.w@mfa.go.th) during 2-12 April 2023. The Embassy will select participants that meet all the requirements and will announce the final result no later than 20 April 2023.

Applications will be considered on a first-come, first-served basis and will also take into consideration other relevant factors (**the Royal Thai Embassy, Bucharest reserves the right to select participants as deemed appropriate**).

### \*\*\*Regulations, Terms and Conditions\*\*\*

- Selected participants are responsible for acquiring relevant permits/licenses, as well as observing and strictly abiding by the related regulations. The Royal Thai Embassy, Bucharest assumes no responsibility if the participants are fined or prohibited from selling products by the local authorities concerned.
- Selected participants shall strictly follow the regulations, terms and conditions established by the Royal Thai Embassy, Bucharest and the regulations of the event venue. **Participants shall assume full responsibility in case of damages that occur from negligence or non-compliance with the regulations, terms and conditions in force.**
- Selected participants shall strictly follow the safety regulations on fire prevention. **Smoking, using open fire or tools that will cause fire in the event areas are strictly prohibited.**
- **Selected participants may not bring any vehicles inside and park vehicles in the event areas.**
- **Selected participants are permitted to use electricity only at the designated areas under permission and supervision of the officers. The use of electricity is allowed for reheating food only.**
- Selected participants shall maintain cleanliness of the designated areas for food selling. The participants shall follow hygienic practice, sort, and dispose garbage in the provided areas.
- The Royal Thai Embassy, Bucharest will allocate areas for Thai food and Thai products selling (free of charge) to selected participants. However, participants are obliged to bring their own utensils/equipment, including decoration materials to be used at their booths.
- **The Royal Thai Embassy, Bucharest assumes no liability in case of damages caused by weather conditions, natural disaster, other types of disasters, or unforeseeable circumstances which may result in postponement or cancellation of the Thai Festival.**
