- Must be an original Invitation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution, school or university
- Must address to "Royal Thai Consulate-General in Fukuoka"
- Must contain the applicant's name / parent or guardian's name / relationship between the applicant and parent or guardian / purpose of stay / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorized representative (electronic signature is not acceptable)

5. Recommendation Letter issued by educational institution in Japan

- Must be an original Recommendation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution
- Must address to "Royal Thai Consulate-General in Fukuoka"
- Must contain the applicant's name / parent or guardian's name / relationship between the applicant and parent or guardian / purpose of stay / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorized representative (electronic signature is not acceptable)
- **X** In case that the Recommendation Letter from educational institution in Japan cannot be shown, an original guarantee letter must be presented together with a copy of guarantor's passport or driving license duly signed by the guarantor

Guarantee Letter (downloadable at https://fukuoka.thaiembassy.org/en/content/thvisa041922-2)

- A guarantor must be 20 years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (legally residing in Japan with permanent residence)
- ➤ In the English Guarantee Letter, a guarantor must sign as the same as the guarantor's identification document signature
- > Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license

6. Official documents proving family relationship with the applicant
