

## Non-Immigrant O Visa (For Parents or Guardians of Students Enrolling in Thailand)

<b>Purpose of Entry</b>	For parents or guardians of students enrolling at formal educational institutions which approved by the Ministry of Education of Thailand (only elementary, junior and high schools)  For parents or guardians of students enrolling at international schools or international programmes in private universities (only elementary, junior and high schools)	<b>Number of Entry</b>	Single (1 time of entry)
<b>Term of Validity</b>	3 months	<b>Duration of Stay</b>	90 days
<b>Visa Fee (Cash Only)</b>	10,000 Yen		
<b>Notice</b>	<ul style="list-style-type: none"> <li>● Applicant must enter Thailand on the date specified in the airline ticket or ticket reservation confirmation</li> <li>● Upon arrival to Thailand, the period of stay is granted by an immigration officer in accordance with the type of visa; travelers who wish to stay longer than the granted period must file an application for permission of extension of stay at offices of the Immigration Bureau of Thailand</li> <li>● In case that visa application is rejected, the visa fee will not be refunded and submitted documents will not be returned to the applicant</li> <li>● The following required documents are subject to change without prior notice</li> <li>● Royal Thai Consulate-General in Fukuoka reserves the right to request additional documents as deemed necessary and reserves the right to reject an application without providing any reasons</li> <li>● Fraud or misrepresentation can result in permanent visa ineligibility</li> </ul>		

### Required Documents

**1. Passport and a copy of passport photo page**

- Passport with validity not less than 6 months
- At least 2 blank pages left
- One copy of passport photo page

**2. Visa Application Form**

- One Visa Application Form completely filled out and signed as the same as the applicant's passport signature  
 (downloadable at <https://fukuoka.thaiembassy.org/en/content/thvisa041922-2>)

## 2. One Photograph

- Size 3.5 cm × 4.5 cm
- Colour photograph taken within the last 3 months
- Attach the photograph to the Visa Application Form
- Note that the number of photographs required depending on the applicant's nationality, please check the Additional Required Documents for Non-Japanese Applicants below

## 3. Personal History

- One Personal History completely filled out and signed as the same as the applicant's passport signature  
(downloadable at <https://fukuoka.thaiembassy.org/en/content/thvisa041922-2>)

## 4. Invitation Letter issued by educational institution, school, or university in Thailand

- Must be an original Invitation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution, school or university
- Must address to “Royal Thai Consulate-General in Fukuoka”
- Must contain the applicant's name / parent or guardian's name / relationship between the applicant and parent or guardian / purpose of stay / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorized representative (electronic signature is not acceptable)

## 5. Recommendation Letter issued by educational institution in Japan

- Must be an original Recommendation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution
- Must address to “Royal Thai Consulate-General in Fukuoka”
- Must contain the applicant's name / parent or guardian's name / relationship between the applicant and parent or guardian / purpose of stay / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorized representative (electronic signature is not acceptable)

※ **In case that the Recommendation Letter from educational institution in Japan cannot be shown, an original guarantee letter must be presented together with a copy of guarantor's passport or driving license duly signed by the guarantor**

**Guarantee Letter** (downloadable at <https://fukuoka.thaiembassy.org/en/content/thvisa041922-2>)

- A guarantor must be 20 years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (legally residing in Japan with permanent residence)
- In the English Guarantee Letter, a guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license

**6. Official documents proving family relationship with the applicant**

- For Japanese national, an original Household Registration issued within 3 months
- For Non-Japanese nationality, birth certificate of your country with English translation is required

**7. One copy of the student's passport photo page**

**8. One copy of every page with Stay Permit stamps for Non-Immigration ED Visa in the passport of the student (if any)**

**9. One copy of confirmed airline ticket paid in full or ticket reservation confirmation**

- The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

**10. In case that the student prefers to travel together with their parent or guardian on the same date, it will be as follows**

- Not required to submit the Document No. 8
- Must submit the visa applications of the Student and the parent or guardian on the same day
- Must travel to Thailand together on the same day
- Must submit one copy of confirmed airline ticket paid in full or ticket reservation confirmation of the student

**Additional Required Documents for Non-Japanese Applicants**

**11. One copy of residence card or certificate of alien registration**

(On the applying date, please present the original document of identification)

- Valid for at least 3 months
- For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan

**12. Additional Photograph(s) (Only for the applicant from the listed countries below)**

- Applicant with nationality of No. 1-28, please provide 3 photographs
- Applicant with nationality of No. 29-30, please provide 4 photographs
