5.3	A medical certificate issued from the country where the application is submitted, showing no prohibitive diseases (Leprosy, Tuberculosis, drug addiction, elephantiasis, third phase of syphilis) as indicated in the Ministerial Regulation No. 14 (B.E. 2535) (certificate shall be valid for not more than three months and should be notarized by notary offices or the applicant's diplomatic or consular mission)		
5.4	In the case where the accompanying spouse is not eligible to apply for the Category 'O-A"(Long stay) visa he or she will be considered for temporary stay under category 'O' visa.
