# 申请旅游签证的规定

# (以旅游、探亲或是访友为目的的签证)

单次入境旅游签证

签证有效期:从签证签发日起90天有效

停留期限:不超过 60 天 签证费用:人民币 240 元

申请材料:

- 1. 有效期超过6个月的护照:
- 2. 有效的身份证件;
- 3. 护照规格的近期电子彩照:
- 4. 确认往返泰国日期的飞机票(电子客票行程单)/车票/船票;
- 5. 在泰国停留期间入住酒店的预订单;
- 6. 工作单位证明原件(英文书写),须用单位专用信函纸打印,请注明申请人的姓名、护照号码、职位、工资收入,以及往返泰国旅游时间,并担保申请人在泰国期间遵守泰国法律且按时回国,该证明须有单位负责人签名并加盖公章;
  - \* 对未满 18 周岁的未成年儿童材料要求:该儿童的出生证和户口册 (若该儿童不与父母同行,必须出示父母同意该儿童旅行的英文或泰语证明信件。)
  - \* 对退休人员的材料要求: 退休证
- 7. 若无工作单位无法提供单位证明,申请人须提供有效的银行存款证明,或者提交签证申请当日打印的近半年银行流水对账单,且余额不低于 5,000 人民币/人 (银行开具);
  - 8. 若自驾车前往泰国, 需增加以下资料:
    - 8.1 驾驶证;
    - 8.2 行驶证:
    - 8.3 工作单位证明必须注明所驾驶车辆及乘坐该车辆人员名单及个人信息;若无工作单位证明,则由自驾车人员写英文担保信,须注明所驾驶车辆及乘坐该车辆人员名单及个人信息。
    - 8.4 旅游行程。

### 备注:

- 1. 申请者必须通过电子签证申请网站 www. thaievisa. go. th 进行申请,并按照要求通过系统提交相关文件。签证获批后,申请者将会收到电子邮件和系统通知,您的签证将以"无贴纸"形式签发,系统会向申请者的电子邮箱发送签证通知函,可从系统下载。建议签证申请者在出行前打印签证通知函以便移民检查站审查。
  - 2. 泰王国驻昆明总领事馆只受理以下签证申请者所提交的申请:
    - -护照"签发地点"为云南省、贵州省和湖南省的中国公民;
    - -持有由云南省、贵州省和湖南省签发的中华人民共和国港澳台居民居住证的

## 香港、澳门或台湾居民:

- -持有由云南省、贵州省和湖南省签发的中华人民共和国居留许可的外国人。
- 3. 申请者必须通过系统提交清楚、清晰、高质的真实文件扫描件。泰领馆根据情况会要求补充文件和/或面签(通过电子方式或亲自面签)。如果提交的材料被发现是伪造的文件,或未经授权进行涂改的文件,签证申请将被拒绝。
- 4.持过境签证和旅游签证入境时,泰王国移民局官员有权抽查每个人所携带现金的数量。过境签证每人不少于1万泰铢,每个家庭不少于2万泰铢;旅游签证每个人不少于2万泰铢,每个家庭不少于4万泰铢。

# 签证延期及停留:

#### **TOURIST VISA - Single Entry**

**VALIDITY OF VISA:** 90 days from the date of issuance

**PERMIT TO STAY:** not exceeding 60 days

FEE: 240 RMB

**DOCUMENTS:** 1. Passport with a validity of not less than 6 months.

2. ID card.

- 3. A recent passport-sized electronic photo.
- 4. A confirmed roundtrip transportation ticket (air/boat/bus) with particular dates of departure and return
- 5. A confirmed hotel booking covering the period of stay in Thailand.
- 6. Guarantee Letter (in English or Thai) from the applicant's local guarantor, indicating the applicant's name, position, wage, purpose and period of stay in Thailand and guaranteeing that the applicant will come back to China as scheduled. The letter must include official letterhead of the company/school and affix with official seal.
  - \* <u>Persons under 18 years of age</u>: the original birth certificate and household registration with one copy of each. If the underaged person is not traveling with a parent, there should be a certified letter from the parents, giving permission for traveling.
  - \* Retirees: the original retirement certificate with one copy.
- 7. For those without a guarantee letter, must submit a valid certificate of deposit from the bank or bank statement not less than 6 months with bank official seal, with minimum balance of 5,000 RMB.
- 8. <u>For those who wish to drive to Thailand</u>, additional documents are required as follows:
  - 8.1 Driving license;
  - 8.2 Car Registration;
  - 8.3 Guarantee letter must also include the name list of passengers travelling in the car. Those without the guarantee letters must submit written notes (typed or handwritten) specifying the name of the driver and the name list of passengers travelling in the car;
  - 8.4 Draft programme of visit to Thailand.

### **NOTE**

- 1. Applications must be submitted using the "E-Visa" system, through the website <a href="www.thaievisa.go.th">www.thaievisa.go.th</a>. All applicants will be requested to submit relevant documents through the system. Once the visa is approved, applicants will be notified by email and on the system, and your visa will be issued in "stickerless" format. A notification letter will be sent by the system to your email, and downloadable from the system. Before traveling, the visa applicant is advised to print the said letter to present at immigration checkpoints, if requested.
- 2. The RTCG Kunming will only process visa applications submitted by:
  - Chinese nationals who are resident in Yunnan, Guizhou, or Hunan Province, as shown by the "PLACE OF ISSUE" on your passport;
  - Hong Kong, Macau, or Taiwan residents whose resident permits in the People's Republic of China were issued in Yunnan, Guizhou, or Hunan Province; and
  - Non-Chinese foreign nationals whose resident permits for the People's Republic of China were issued in Yunnan, Guizhou, or Hunan Province.
- Applicants must submit clear, legible, and good-quality scans of their authentic documents through the system. The RTCG may request further documents and/or interviews (electronically or in person), as necessary. IF DOCUMENTS SUBMITTED ARE FOUND TO BE FAKE, OR ADJUSTED WITHOUT AUTHORISATION, YOUR VISA APPLICATION WILL BE REFUSED.
- 4. Visitors who enter Thailand will be randomly checked for travelling expenses by immigration officers. Visitors are advised to have with them minimum amount of (for Transit) 10,000 Baht/person or 20,000 Baht/family and (for Tourist) 20,000 Baht/person or 40,000 Baht/family when visiting Thailand.

### **EXTENSION OF STAY**

Those who wish to stay longer must apply to the relevant offices of the Thai Immigration Bureau, or at a provincial Immigration Office (see: http://www.immigration.go.th) in Thailand. Extensions of stay and changes of visa type are solely at the discretion of the Immigration Bureau.
