



**Announcement No.5 on the Entry Procedures for Non-Thai Nationals
Who are Eligible to Enter the Kingdom of Thailand, Pursuant to
the Regulation Issued under Section 9 of the Emergency Decree on
Public Administration in Emergency Situations B.E. 2548 (2005)**

With reference to the Royal Thai Embassy's Announcement No. 4 on the Entry Procedures for Non-Thai Nationals Who are Eligible to Enter the Kingdom of Thailand, Pursuant to the Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) No. 12 and No. 13 and pursuant to the Order of the Centre for the Administration of Situation due to the Outbreak of the Communicable Disease Coronavirus (COVID-19) No. 4/2564 on Guidelines based on Regulations Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situation B.E. 2548 (2005) dated 31 March 2021, the Royal Thai Embassy wishes to announce an update on the process of the application for all categories of visa and COE for the eligible non-Thai nationals who wish to enter into Thailand from April 2021 onwards by travelling in any semi-commercial flights from the Republic of Korea to the Kingdom of Thailand as follows:

Note: The whole process of the application for visa and a Certificate of Entry (COE) takes around 8-10 working days. The applicant is required to plan the trip carefully to minimize the possibility of not getting the visa and COE in time.

Step 1: Please check whether the applicant has already acquired a valid visa.

1.1 If the eligible applicant does not have a valid visa, please proceed to step 2.

1.2 If the eligible applicant has a valid visa, please skip to step 5.

Step 2: Applicant books the date to submit the required documents for visa via the link: <https://forms.gle/eFVABMvHS92iRY737> or QR Code:



Note:

- Diplomatic Passport holders and Official Passport holders are not required to make an online appointment.
- The applicant must not apply for a visa earlier than 3 months before travelling.

Step 3: Applicant submits the following documents at the Embassy's visa section on an appointment date that is booked via the link/ QR code in step 2 *(Please note that visa section opens Monday-Friday from 09.00 hrs. to 12.00 hrs. and the issuance of visa takes 5 working days, excluding the submission date.)*:

3.1 A valid passport;

3.2 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000 or equivalent in other currencies. The insurance must cover the entire duration of stay in Thailand;

3.3 A copy of the Declaration Form completely filled-in and signed (Download the declaration form at: <https://docdro.id/Js2psc3>);

3.4 A visa application form completely filled-in and signed;
and

3.5 Additional required documents for each type of visa application.

Note: The list of 11 categories of non-Thai nationals that are eligible to enter the Kingdom of Thailand and the full list of required documents for each type of visa application are as in attachments.

Step 4: Applicant picks up visa and instruction on how to apply for an online COE at the Embassy's visa section on the appointment date.

(Please note that the issuance of an online COE takes at least 3-5 working days.)

Step 5: Applicant applies for an online COE via <https://coethailand.mfa.go.th>

Step 5.1 Applicant registers for COE application by filling in personal details and uploading supporting documents.

Step 5.2 Applicant who has been pre-approved can book

5.2.1 Semi-commercial flight ticket from the permitted airline such as Thai Airways (TG), Korean Air (KE), and Asiana Airlines (OZ).

5.2.2 Alternative State Quarantine (ASQ) or Alternative Local Quarantine (ALQ) List of ASQ/ALQ facilities can be found at <http://hsscovid.com>

**Update on Thailand's Quarantine Measures from 1 April 2021, 00.01 hrs.
(Thailand time) onwards,**

- Quarantine period will be reduced from 14 days (15 nights) to 10 days (11 nights) for travelers from countries with no mutated strain of the coronavirus.
- Travelers from countries with cases of COVID-19 variant strains are subjected to 14-day quarantine.
- For travelers with a vaccine certificate in English or with English translation and traveling from countries with no cases of COVID-19 variant strains may be eligible to undergo no less than 7-day quarantine. This condition will only apply to those who have been vaccinated in complete doses against COVID-19 with certain types of vaccine approved by the World Health Organization (WHO) or Ministry of Public Health of Thailand for no less than 14 days before the travelling date.
- Travelers must present vaccine certificate (an original paper or a print out of online vaccine certificate) to International Port Health Control at the port of arrival, otherwise the travelers may be quarantined for no less than 10 days. The said current list of vaccines includes

- The list of countries with mutated strain of the coronavirus will be determined and updated monthly by the Ministry of Public Health of Thailand.

Step 5.3 Applicant uploads a copy of an e-ticket and a copy of confirmed reservation of ASQ or ALQ online.

Step 5.4 When the COE has been approved, applicant can download and print out the online COE.

Step 6: Applicant must download ThailandPlus Application on mobile phone and present the following documents at the port of the embarkation and upon entry into the Kingdom of Thailand:

6.1 A valid visa or a valid re-entry permit;

6.2 A COE;

6.3 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000.- (or equivalent in other currencies).

Travelers are advised to purchase the health insurance that meets Thailand's entry criteria from

6.4 A medical certificate with RT-PCR laboratory result indicating that COVID-19 is not detected, issued no more than 72 hours before travelling; and

6.5 (If vaccinated) An original vaccine certificate or a copy of online vaccine certificate.

**The Categories of Non-Thai Nationals that are Eligible to
Enter the Kingdom of Thailand**

The categories of non-Thai nationals that are eligible to enter the Kingdom of Thailand according to (1) The Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 12) and (2) The Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 13):

(1) Exempted persons or persons who are specified, permitted or invited by the Prime Minister or Chief Official responsible for remedying the emergency situation to enter into the Kingdom pertaining to necessity, whereby conditions and timeframes may also be prescribed;

(2) Persons on diplomatic or consular missions or under international organisations, or representatives of foreign governments or agencies performing their duties in Thailand, or any other persons in international agencies, that the Ministry of Foreign Affairs gives permission pertaining to necessity, including their spouses, parents or children;

(3) Carrier of goods pertaining to necessity, who shall promptly depart after completing their mission;

(4) Crew members who are required to travel into the Kingdom on a mission, and have a specified date and time for return;

(5) Non-Thai nationals who are spouses, parents, or children of Thai nationals;

(6) Non-Thai nationals who have certificate of residence or have been permitted to take up residency in the Kingdom, including their spouses or children;

(7) Non-Thai nationals who have work permit or have been granted permission to work in the Kingdom in accordance with Thai laws, including their spouses or children;

(8) Non-Thai nationals who are students of educational establishments in Thailand approved by Thai authorities, including their parents or guardians, except for students of non-formal schools in accordance with laws on private schools or of any other similar private educational establishments;

(9) Non-Thai nationals who need to receive medical treatment in Thailand, including their accompanying persons, except for treatment for COVID-19;

(10) Non-Thai nationals who have been granted permission to enter into the Kingdom under special arrangements between Thai government agencies and other countries, or persons or groups of persons who have been granted permission by the Prime Minister upon the submission for consideration after the examination and review by the Ad Hoc Committee for the Consideration of the Relaxation of the Enforcement of Measures to Prevent and Suppress the Spread of the Communicable Disease Coronavirus 2019 (COVID-19), and shall comply with disease prevention measures determined by the Ad Hoc Committee; and

(11) Non-Thai nationals who have been granted permission to enter into the Kingdom of Thailand according to the Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 13) are as follows:

(11.1) Non-Thai nationals who wish to obtain long stay visa;

(11.2) Non-Thai nationals who hold a Thailand Elite Card / Thailand Privilege Card;

(11.3) Holders of APEC Card;

(11.4) Non-Thai nationals who wish to do business or make an investment in Thailand but do not have work permit;

(11.5) Non-Thai Nationals who wish to enter Thailand for media production or filming;

(11.6) Non-Thai Nationals from Countries/Territories that are Entitled for Visa Exemption Scheme;

(11.7) Non-Thai nationals who wish to stay in Thailand for the period of up to 60 days (Tourist Visa);

(11.8) Non-Thai nationals who wish to stay in Thailand for the period of up to 90 days (Special Tourist Visa);

(11.9) Non-Thai nationals who are retired and receive pension from the government;

(11.10) Non-Thai nationals who wish to enter Thailand to perform religious work (Non-immigrant Visa Category R);

(11.11) Non-Thai nationals who wish to enter Thailand to perform religious work with multiple entries (Non-immigrant Visa Category R-A);

(11.12) Non-Thai nationals who wish to travel in transit through the Kingdom of Thailand in order to proceed to the country of Destination or to re-enter his/her own country: (Transit Visa: Category 'TS');

(11.13) Non-Thai nationals who wish to participate in sports activities in the Kingdom of Thailand (Transit Visa: Category 'S');

(11.14) Non-Thai nationals who are crews of a conveyance coming to a port, station or area located in the Kingdom of Thailand: (Transit Visa: Category 'C');

(11.15) Non-Thai nationals who wish to participate in volunteering work in the Kingdom of Thailand or who are former Thai citizen or who have to appear in court (Non-immigrant Visa Category O); and

(11.16) Non-Thai nationals who wish to enter Thailand to attend short training course or to participate in study tour or internship programme or to study or practice the Dhamma (Teaching of Buddha) (Non-immigrant Visa Category ED).

**Persons on Diplomatic or Consular Missions or under
International Organisations, or Representatives of Foreign Governments
or Agencies Performing Their Duties in Thailand, or any other Persons in
International Agencies, that the Ministry of Foreign Affairs Gives
Permission Pertaining to Necessity, including their Spouses,
Parents or Children**

1. Valid passport;
2. A copy of applicant's valid passport;
3. A filled-in visa application form;
4. Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
5. A diplomatic note from the country's government of the applicant confirming the official status of the applicant and official purpose of travel;
6. A letter from the respective DCIOs affirming responsibility for healthcare or treatment expenses, or documentary evidence demonstrating a guarantee that the traveler is able to take responsibility for his/her own healthcare or treatment expenses, including for COVID-19, throughout the duration of stay in the Kingdom of Thailand;
7. A copy of the Declaration Form completely filled-in and signed; and
8. A Certificate of Entry (COE) approved by the Ministry of Foreign Affairs of Thailand.

**Non-Thai Nationals who are Spouses, Parents, or
Children of Thai Nationals**

1. For spouses of Thai nationals:

- 1.1 Valid passport;
- 1.2 A copy of applicant's valid passport;
- 1.3 A copy of Thai spouse's valid passport or ID card;
- 1.4 A filled-in visa application form;
- 1.5 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
- 1.6 A copy of a marriage certificate or other documents to certify marriage;
- 1.7 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000.- (or equivalent in other currencies); and
- 1.8 A copy of the Declaration Form completely filled-in and signed.

2 For parents of Thai nationals:

- 2.1 Valid passport;
- 2.2 A copy of applicant's valid passport;
- 2.3 A copy of Thai child's valid passport or ID card;
- 2.4 A filled-in visa application form;
- 2.5 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
- 2.6 A copy of a family registration certificate or other documents to certify family relations;

- 2.7 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000.- (or equivalent in other currencies); and
- 2.8 A copy of the Declaration Form completely filled-in and signed.

3. For children of Thai nationals:

Non-Thai Nationals who Have Certificate of Residence or Have Been Permitted to Take Up Residency in the Kingdom, including Their Spouses or Children

1. For non-Thai nationals who have certificate of residence:
 - 1.1 Valid passport;
 - 1.2 A copy of applicant's valid passport;
 - 1.3 A filled-in visa application form;
 - 1.4 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
 - 1.5 A copy of certificate of residence;
 - 1.6 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000.- (or equivalent in other currencies); and
 - 1.7 A copy of the Declaration Form completely filled-in and signed.

2. For spouses of non-Thai nationals who have certificate of residence:

- 2.1 Valid passport;
- 2.2 A copy of applicant's valid passport;

including Their Spouses or Children**

1. For non-Thai nationals who have been granted permission to work in the Kingdom:

- 1.1 Valid passport;
- 1.2 A copy of applicant's valid passport;
- 1.3 A filled-in visa application form;
- 1.4 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
- 1.5 A copy of recent bank statement (45,000 Baht per person and 90,000 Baht per family) In case of submitting a family bank statement, a proof of relationship must be provided;
- 1.6 Applicant's resume;
- 1.7 For non-Korean citizen, a copy of alien registration card or a copy of valid work visa with a proof of employment;
- 1.8 Supporting documents
 - (a) Documents required for Non-Immigrant category "B" (Working):
 - Letter from applicant's company indicating the applicant's position, length of employment, salary, purpose of visit, and length of stay in Thailand;
 - A copy of valid work permit or work permit 3 (WP.3);

- Alien income tax or Por Ngor Dor 9;
(If an applicant has previously worked in Thailand);
- Corporate documents:
 - Business registration
 - Business license
 - List of shareholders
 - Company profile
 - Details of business operation
 - Map indicating location of the company
 - Balance sheet
 - Statement of Income Tax and Business Tax (Por Ngor Dor 50 and Por Ngor Dor 30) of the latest year
 - Value-added tax registration (Por Por 20)

(b) Documents required for Non-Immigrant category “B” (Teaching):

- An original letter of acceptance from a school or university in Thailand
 - Evidence of educational qualification
 - A copy of school (in Thailand) license or business registration, list of shareholders, and school profile
 - Applicant’s resume

- 1.10 A copy of the Declaration Form completely filled-in and signed.

Non-Thai nationals who are Students of Educational Establishments in Thailand Approved by Thai Authorities, including Their Parents or Guardians, Except for Students of Non-formal Schools in accordance with Laws on Private Schools or of Any Other Similar Private Educational Establishments

1. For non-Thai nationals who are students of educational establishments in Thailand approved by Thai authorities:
 - 1.1 Valid passport;
 - 1.2 A copy of applicant's valid passport;
 - 1.3 A filled-in visa application form;
 - 1.4 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
 - 1.5 A document confirming the parent's employment;
 - 1.6 A copy of recent bank statement (45,000 Baht per person and 90,000 Baht per family) In case of submitting a family bank statement, a proof of relationship must be provided;
 - 1.7 An original letter of acceptance or invitation or a letter to prove student status from the schools and universities or institutes that are approved by Thai authorities;
 - 1.8 Evidence of accommodation in Thailand;
 - 1.9 For non-Korean citizen, a copy of alien registration Card;
 - 1.10 In case of students under 20 years old travelling alone, please provide:

- (1) Notarized copy of a birth certificate
- (2) Notarized copy of marriage certificate
(In case of sole custody, notarized copy of court order must be provided)
- (3) Notarized copy or *original* passports or ID of mother and father/ legal guardian
- (4) Original letter of notarized consent for the minor to travel abroad from mother and father/ legal guardian;

**** All supporting materials that are not in English must be accompanied by certified English translations and certified by an embassy only. ****

- 1.11 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000.- (or equivalent in other currencies); and
- 1.12 A copy of the Declaration Form completely filled-in and signed.

2. For parents or guardians of non-Thai nationals who are students of educational establishments in Thailand approved by Thai authorities:

- 2.1 Valid passport;
- 2.2 A copy of applicant's valid passport;
- 2.3 A filled-in visa application form;
- 2.4 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
- 2.5 A copy of recent bank statement (45,000 Baht per person and 90,000 Baht per family) In case of submitting a family bank statement, a proof of relationship must be provided;

- 2.6 Student's original letter of acceptance or invitation or a letter to prove student status from the schools and universities or institutes that are approved by Thai authorities;
- 2.7 Evidence of accommodation in Thailand;
- 2.8 A copy of a birth certificate or other documents to certify relationship with the student;
- 2.9 For non-Korean citizen, a copy of alien registration Card;
- 2.10 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000.- (or equivalent in other currencies); and
- 2.11 A copy of the Declaration Form completely filled-in and signed.

Non-Thai Nationals who Need to Receive Medical Treatment (Except for Treatment for COVID-19) in Thailand, including Their Accompanying Persons (no more than 3 accompanying immediate family members)

1. Applicant contacts hospital in Thailand that has been approved by the Ministry of Public Health (MOPH) to receive foreign patients and quarantine foreign patients in order to send a request to enter into Thailand to the Department of Health Service Support (HSS).

2. Once approved, the HSS will send the list of approved patients and accompanying family members to the Ministry of Foreign Affairs which will inform the Embassy to issue a Certificate of Entry (COE) and visa.

3. The applicant submits the following required documents for visa application at the Royal Thai Embassy:

3.1 For Non-Thai Nationals who Need to Receive Medical Treatment:

- 3.1.1 Valid passport;
- 3.1.2 A copy of applicant's valid passport;
- 3.1.3 A filled-in visa application form;
- 3.1.4 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
- 3.1.5 A copy of confirmation letter with the stamp of MOPH (Letter of certification from the hospital in Thailand confirming the admission of the patient and the arrangement of quarantine facility within the hospital for the period of full 14 days for the patient and his/her accompanying persons);
- 3.1.6 A copy of Affidavit of Support with the stamp from MOPH (for family members);

- 3.1.7 A copy of the Declaration Form completely filled-in and signed;
- 3.1.8 Bank statement that covers the cost of medical treatment in Thailand; and
- 3.1.9 A health insurance policy covering treatment and medical expenses related to COVID-19 with a minimum coverage of USD 100,000.- (or equivalent in other currencies).

3.2 For immediate family members of non-Thai nationals who need to receive medical treatment in Thailand:

- 3.2.1 Valid passport;
- 3.2.2 A copy of applicant's valid passport;
- 3.2.3 A filled-in visa application form;
- 3.2.4 Recent (3.4x4.5 cm) colour photograph, taken within 6 months, with applicant's first name and last name written on the back of each photo);
- 3.2.5 A copy of valid passport of non-Thai nationals who need to receive a medical treatment in Thailand;
