## New Regulations on Entry to Thailand by Air after 1 June 2022

As the COVID-19 situation in Thailand has improved and many countries have eased measures and requirements related to Covid-19 disease, Thailand's Centre for COVID-19 Situation Administration (CCSA), in accordance with Thailand's reopening policy, issued Regulation No. 11/2565 on 30 May 2022 to revise travel requirements and lift quarantine for the entry to Thailand after 1 June 2022 as follows:

**1.** <u>Thai nationals are not required to register for Thailand Pass</u>. Upon arriving in Thailand, health control authorities will check the following documents:

1.1 Certificate of Vaccination or

1.2 For unvaccinated or not fully vaccinated travellers, negative RT-PCR **or** professional ATK test (not self-ATK test) within 72 hours of travel.

2. Foreign nationals are required to register for Thailand Pass at the website: https://tp.consular.go.th:

**2.1 For fully vaccinated travellers**, please attach (1) passport (2) certificate of vaccination and (3) health insurance with minimum coverage of 10,000 USD for medical expenses in the Thailand Pass Registration System.

**2.2** <u>For unvaccinated / not fully vaccinated travellers</u>, please attach (1) passport (2) negative RT-PCR or professional ATK test within 72 hours of travel and (3) health insurance with minimum coverage of 10,000 USD for medical expenses in the Thailand Pass Registration System.

After foreign nationals have completed their registration, they will automatically be issued a Thailand Pass QR Code within 1 - 2 hours. The QR Code will be valid for 72 hours after the original date of arrival. Please note that

the airlines will check QR Code and related documents upon check-in. After the travellers arrive in Thailand, they will also undergo entry screening by health control authorities.

3. **For foreign nationals under the age of 18 with a Thai parent**, the Thai parent is required to register for Thailand Pass and attach his/her children's required documents in the Thailand Pass Registration System.

4. <u>Foreign nationals</u> are required to have health insurance with <u>minimum</u> <u>coverage of 10,000 USD for medical expenses</u>. The insurance is not required for Thai nationals and foreign nationals who have Thai social security or confirmation letters from employers in Thailand.
