### **New Regulations on Entry to Thailand by Air after 1 May 2022**

As the COVID-19 situation in Thailand has gradually improved and many countries have eased measures and requirements related to Covid-19 disease, Thailand's Centre for COVID-19 Situation Administration (CCSA) issued Regulation No. 9/2565 on 29 April 2022 to revise requirements for the entry to Thailand after 1 May 2022 in order to facilitate travellers as follows:

1. All travellers are required to register for Thailand Pass Registration System before entering Thailand.

**1.1 Travellers who are fully vaccinated** can enter Thailand without quarantine and are not required to take a Covid-19 test, both prior to and after arriving in Thailand.

**1.2 Travellers who are not vaccinated or have not been fully vaccinated** can enter Thailand under 2 options as follows:

**1.2.1 Exemption from Quarantine:** Travellers must have **a negative RT-PCR test result issued within 72 hours** before traveling and upload the test result on Thailand Pass Registration System. An additional RT-PCR test once arriving in Thailand is not required.

**1.2.2 Quarantine:** Travellers who do not have a negative RT-PCR test within 72 hours before travelling must **stay in quarantine for 5 days at an Alternative Quarantine (AQ) hotel**. Hotel receipt must include the fee for 1 RT-PCR test and airport transfer. Travellers will take the RT-PCR test on Day 4 or 5. (This is similar to the previous AQ Programme)

### **Entry Measures for Travellers by Air**

Proof of Payment for Hotel Accommodation	-	<u>Quarantine:</u> upload an Alternative Quarantine (AQ) hotel receipt for 5 days, including 1 RT-PCR test and airport transfer on Thailand Pass Registration System.
Proof of Insurance with at least 10,000 USD Coverage for Medical Treatments	✓ (Not required for Thai travellers)	

2. **Non-Thai travellers** are required to have insurance with **minimum coverage of 10,000 USD for medical expenses** (previously 20,000 USD). The insurance is not required for Thai nationals and foreign nationals who have Thai social security or confirmation letters from employers in Thailand

3. Travelers whose Thailand Pass have already been issued can travel with the issued QR Code and do not need to register for new Thailand Pass. However, unvaccinated or not fully vaccinated travellers who have been approved to enter Thailand under AQ scheme but wish to enter Thailand under exemption from quarantine must re-apply on Thailand Pass.
