The Ministry of Foreign Affairs presents its compliments to all Diplomatic Missions, Consular Representatives and International Organisations (DCIOs) in Thailand and, with reference to the Ministry's Immediate Note No. 0404/c.1339 dated 14 July B.E. 2563 (2020) requesting members of the DCIOs to strictly adhere to the COVID-19 disease prevention measures laid out by the Royal Thai Government, has the honour to inform the latter as follows:

1. The Centre for COVID-19 Situation Administration (CCSA) has issued Order No. 8/2563 concerning Guidelines based on Regulations issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No.7) which came into effect on 1 August B.E. 2563 (2020). The Order outlines updated provisions on COVID-19 disease prevention measures as well as the classification of individuals who are permitted to enter into the Kingdom of Thailand, including members of the DCIOs and their families. Procedural requirements to safeguard public health before entry, upon arrival and quarantine measures during their stay in the Kingdom are stated in the Order. An unofficial English translation of the above-mentioned Order is attached herewith for the DCIOs' information and reference.

2. The Ministry wishes to express its profound appreciation to the DCIOs for its continued support and cooperation with the Royal Thai Government's COVID-19 disease prevention measures which have been constantly reviewed and revised as deemed appropriate based on current global and local situations. The Ministry will keep the DCIOs informed of any further developments of the Government's COVID-19 measures in due course.

The Ministry of Foreign Affairs avails itself of this opportunity to renew to all Diplomatic Missions, Consular Representatives and International Organisations in Thailand the assurances of its highest consideration.

Order of the Centre for the Administration of the Situation due to the Outbreak of the Communicable Disease Coronavirus 2019 (COVID-19) No. 8/2563

Re : Guidelines based on Regulations issued under Section 9

of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005)

(No. 7)

Pursuant to the Resolution of the Council of Ministers adopted on 29 July B.E. 2563 (2020) extending the duration of the enforcement of the Declaration of an Emergency Situation in all areas of the Kingdom of Thailand as from 1 August B.E. 2563 (2020) until 31 August B.E. 2563 (2020);

In order to perform tasks under the Regulations issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005), under the Declaration of an Emergency Situation and the extension of its duration, and under the Order of the Prime Minister No. 5/2563 on the Establishment of a Special Task Force to Perform Duties in Accordance with the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005), issued on 25 March B.E. 2563 (2020), and its amendments, in an efficient manner, by virtue of Clause 4 (2) of the Order of the Prime Minister No. 4/2563 on the Appointment of Supervisors, Chief Officials and Competent Officials Responsible for Remedying the Emergency Situation, issued on 25 March B.E. 2563 (2020), and its amendments, the Prime Minister, in the capacity of the Director of the Centre for COVID-19 Situation Administration, hereby orders Chief Officials responsible for remedying the emergency situation and competent officials to strictly carry out functions in accordance with the disease prevention measures annexed to this Order.

This Order shall come into effect as from 1 August B.E. 2563 (2020) until otherwise ordered.

Remarks:

Main Control Measures mean implementing measures under Clause 11 of the Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 1).

Supplementary Measures are measures in addition to Main Control Measures which require cooperation from business operators and activity organisers, including customers and participants, in order to make measures preventing and controlling the spread of the COVID-19 disease more efficient.

Operations manual serves as guidelines and conditions for carrying out business operations and the organisation of activities in each area, in order to maintain prevention measures for the spread of the COVID-19 disease in a continuous manner, and for people to be able to live safely from the spread of COVID-19 disease in accordance with the Sufficiency Economy Philosophy.

Remarks:

- 1. The use of insurance policies issued by companies registered in Thailand which are under the supervision and have been certified by the Office of Insurance Commission should be encouraged and promoted.
- 2. **Exempted persons or persons under (2):** The Prime Minister or Chief Official responsible for remedying the emergency situation may prescribe specific measures as appropriate other than those prescribed in the table.
- 3. Isolation of travellers: Where the communicable disease control officer conducts a screening and finds that the traveller has respiratory symptoms or a fever, or where the result of the COVID-19 diagnostic test by RT-PCR technique confirms the finding

of the disease, or where the traveller has respiratory symptoms or a fever during the quarantine or control for observation, such traveller shall be transferred to the hospital determined by the government.

- 4. Determining the start of the quarantine: when travellers enter into the Kingdom
 - 4.1 For travellers entering into quarantine at the determined place before 12.00hrs, the date of entry into quarantine shall count as the first date of quarantine.
 - 4.2 For travellers entering into quarantine at the determined place from 12.00hrs to 24.00hrs, the day after the date of entry into quarantine shall count as the first date of quarantine.
- 5. Agencies responsible for the supervision of the operation of places of quarantine determined by the government shall consist of:
 - 5.1 The Ministry of Defence shall monitor, supervise and manage places of quarantine designated as State Quarantine (SQ) and Alternative State Quarantine (ASQ);
 - 5.2 The Ministry of Interior shall monitor, supervise and manage places of quarantine designated as Local Quarantine (LQ) and Alternative Local Quarantine (ALQ);
 - 5.3 The Ministry of Public Health shall monitor and supervise the provision of medical services in places of quarantine determined by the government to be in accordance with disease prevention measures during the stay in the Kingdom.
