PAYMENT TO LAWYERS FOR FAMILY MATTERS

NO.	SERVICE PROVIDED	RATES
1.	Joint Petition	RM500 until the conclusion of the case at the High Court
2.	Single Petition	RM1500 until the conclusion of the case at the High Court
3.	Adoption	RM750 until the conclusion of the case at the High Court

1. The above rates are excluding of:
 - (a) Disbursements which shall be charged by the respective lawyers as and when incurred (with proof of payment); and
 - (b) Travelling claim which are set at RM 0.60 per KM and;
 - (c) Courts filing fee imposed by the court.
