	4. Letter of employer mentioning the applicant's name, position, purpose and dates of visit to Thailand For self-employed, business license/registration under the applicant's name must be submitted.
	5. Documents from counterpart in Thailand 5.1 Invitation letter 5.2 A copy of the company's registration, business license with registered capital of at least THB 2 million. 5.3 A copy of the company's list of shareholders 5.4 A copy of the company's latest balance sheet 5.5 A copy of the company's value-added tax (VAT) registration <u>OR</u> Proof that you (1) has full ownership of a condominium in Thailand which worth at least THB 3 million <u>OR</u> (2) has cash in a Thai bank for at least THB 3 million <u>OR</u> (3) hold Thai government bond which worth at least THB 3 million.
	6. A copy of reservation/confirmation of transportation tickets to and from Thailand.
	7. Proof of payment for accommodation for the whole period of stay in Thailand (the receipt must state the tax payer number of the relevant hotel/accommodation)
	8. The applicant's original bank statement or bank book. The bank statement must show the account's name and number, balance and history of transactions of the fund no less than THB 500,000 or equivalent for last 6 months

**Visa Fee:** RM 320.-

Fee is exempted for nationals of Malaysia, Singapore, Republic of Korea and Tunisia.
