If the applicant does not have a valid visa or re-entry permit, the applicant must submit visa application in person at the Embassy. Please make an appointment to submit the visa application at http://lmy.io/RTEKL_B

Note that tourists who are the holders of the passport of [these nationalities](#) are eligible to enter Thailand up to 30 days without a visa. In this case, the applicant can proceed to apply for the COE as above-mentioned website.

Requirements for Certificate of Entry (COE) for diplomats, officials of international organisations and their family members

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) (if required) or copy of a valid re-entry permit
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. An official note issued by the Ministry of Foreign Affairs of Malaysia or respective Embassy or international organization, whichever applicable, requesting the Certificate of Entry, and providing the following information :
 - your name, DOB, position, and intended date of arrival, as well as your family members who will accompany you (if any), with copy of passports
 - affirming the agency's responsibility for healthcare or treatment expenses throughout the duration of your stay in Thailand; or producing a documentary evidence demonstrating a guarantee that the traveller is able to take responsibility for his/her own healthcare or treatment expenses, including for COVID-19, throughout your stay in Thailand, or copy of health insurance policy which covers COVID-19 with a coverage no less than USD 100,000 or equivalent.
5. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fit to Travel Health Certificate
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of an Alternative State Quarantine (ASQ) hotel booking
 5. Letter from the ministry/embassy/international organization, whichever applicable, affirming its responsibility for healthcare or treatment expenses; or a documentary evidence demonstrating a guarantee that the traveller is able to take responsibility for his/her own healthcare or treatment expenses, including for COVID-19, throughout the duration of stay in Thailand, or copy of your insurance policy which covers COVID-19 with a coverage of no less than USD 100,000 or equivalent.

Requirements for Certificate of Entry (COE) for non-Thai nationals who are spouses, parents or children of Thai nationals

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) (if required) or copy of a valid re-entry permit
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Copy of marriage certificate or documents to prove relationship with Thai national
5. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
6. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fit to Travel Health Certificate
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of an Alternative State Quarantine (ASQ) hotel booking
 5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Requirements for Certificate of Entry (COE) for non-Thai nationals who have a Certificate of Residence and their spouse and children

Required documents to submit when you apply for COE at the Embassy:

1. Copy of passport
2. Copy of your Certificate of Residence
3. Copy of a valid re-entry permit
4. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
5. Copy of an [Alternative State Quarantine \(ASQ\)](#) booking for 14 days at one of the hotels approved by the Thai authorities
6. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fit to Travel Health Certificate
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of an Alternative State Quarantine (ASQ) hotel booking
 5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Requirements for Certificate of Entry (COE) for Non-Thai nationals with valid work permit or letter of confirmation to work from relevant Thai government agency, and their spouse and children

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) (if required) or copy of a valid re-entry permit
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Copy of Work Permit or letter of permission to work in Thailand issued by one of the relevant Thai government agencies (Ministry of Labour, Board of Investment, Industrial Estate Authority of Thailand, Sports Authority of Thailand)
5. Copy of marriage certificate / birth certificate (in case of spouse and children of the main applicant)
6. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
7. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fit to Travel Health Certificate
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of an Alternative State Quarantine (ASQ) hotel booking
 5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Requirements for Certificate of Entry (COE) Non-Immigrant visa (B) for business purpose

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) for Tourist Visa (TR) or Non-Immigrant visa (B)
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
2. Fit to Fly/Fit to Travel Health Certificate
3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
4. Copy of an Alternative State Quarantine (ASQ) hotel booking
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Note:

Additional required documents for the holder of re-entry permit:

(1) proof of payment for accommodation for the whole period of stay in Thailand (the receipt must state the tax payer number of the relevant hotel/accommodation)

(2) The applicant's original bank statement or bank book. The bank statement must show the account's name and number, balance and history of transactions of the fund no less than THB 500,000 or equivalent for last 6 months

Requirements for Certificate of Entry (COE) for Non-Thai nationals who are students of educational establishments in Thailand approved by Thai authorities, and their parents

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) or copy of a valid re-entry permit
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Letter confirming enrollment/student status from school or university signed by authorised person
5. Approval letter from concerned authority under the Ministry of Education (Only required in the case of student attending school)
6. Copy of birth certificate (in case of parents of the student)
7. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
8. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fir to Travel Health Certificate
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of an Alternative State Quarantine (ASQ) hotel booking
 5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Requirements for Certificate of Entry (COE) for non-Thai nationals in need of medical treatment in Thailand, except for treatment of COVID-19, including their accompanying persons (if any)

Required documents to submit when you apply for COE at the Embassy:

1. For person who required medical treatment:

- 1.1 Copy of Passport
- 1.2 [Visa application](#) or copy of a valid re-entry permit
- 1.3 [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
- 1.4 Financial evidence that you have sufficient fund to pay for your medical treatment in Thailand, such as bank statement
- 1.5 Confirmation Letter for Alternative Hospital Quarantine (with approval stamp from the Ministry of Health)
- 1.6 A copy of health insurance policy which covers COVID-19 related medical treatment and coverage of no less than USD 100,000

2. For accompanying persons (if any)

- 2.1 Copy of passport
- 2.2 [Visa application](#) or copy of a valid re-entry permit
- 2.3 [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
- 2.4 Affidavit of Support for Alternative Hospital Quarantine (with approval stamp from the Ministry of Health)
- 2.5 Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fit to Travel Health Certificate subject to the condition of the patient
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of Confirmation Letter/Affidavit of support for Alternative Hospital Quarantine (AHQ)
 5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Requirements for Certificate of Entry (COE) for the holders of APEC card or Thailand Privilege card (Thailand Elite card member)

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. APEC Card or Thailand Privilege visa
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
2. Fit to Fly/Fit to Travel Health Certificate
3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
4. Copy of an Alternative State Quarantine (ASQ) hotel booking
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Note:

(1) For the holder of APEC cards, the COE will only be issued for the holder of Malaysian Passports.

(2) For the holders of Thailand Privilege/Elite Cardholders, please contact Thailand Privilege Card Co., Ltd. (Thailand Elite) directly to request for authorization before applying for the COE at the Embassy.

Requirements for Certificate of Entry (COE) for the holder of long stay visa (Non-Immigrant Visa: Category “O-retirement” and “O-A”)

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) (if required) or copy of a valid re-entry permit
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline’s check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
2. Fit to Fly/Fit to Travel Health Certificate
3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
4. Copy of an Alternative State Quarantine (ASQ) hotel booking
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Note:

1. The health insurance submitted for O-A visa application can be used for COE application **only if** it expressly covers treatment and medical expenses in relation to COVID-19 with a minimum coverage of 100,000 USD, while also meeting the specific criteria for O-A visa application.
2. For the holder of re-entry permit for Non-O (retirement), the copy of health insurance policy with inpatient benefit (IPD) of not less than 40,000 Thai Baht per year and out patient benefit (OPD) of not less than 400,000 Thai Baht per year is also required.

Requirements for Certificate of Entry (COE) for the holder of Special Tourist Visa (STV)

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) for Special Tourist Visa
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent. This is a separate requirement from the requirement for STV application. The health insurance submitted for STV application can be used for COE application *only if* it expressly covers treatment and medical expenses in relation to COVID-19 with a minimum coverage of 100,000 USD, while also meeting the specific criteria for STV application.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fit to Travel Health Certificate
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of an Alternative State Quarantine (ASQ) hotel booking
 5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Requirements for Certificate of Entry (COE) for the holder of Tourist Visa (TR)

Required documents to submit when you apply for COE at the Embassy:

1. Copy of Passport
2. [Visa application](#) for Tourist Visa (TR) or Non-Immigrant visa (B)
3. [Declaration form](#), duly completed and signed (including intended **flight details**) with one copy
4. Copy of an [Alternative State Quarantine](#) (ASQ) booking for 14 days at one of the hotels approved by the Thai authorities.
5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.

Required documents to present at airline's check-in counter and upon arrival in Thailand:

1. Certificate of Entry and Declaration form (which you have earlier collected from the Embassy)
 2. Fit to Fly/Fit to Travel Health Certificate
 3. Medical certificate with a laboratory result (test by RT-PCR method) indicating that COVID -19 has not been detected, issued within 72 hours before departure
 4. Copy of an Alternative State Quarantine (ASQ) hotel booking
 5. Copy of health insurance policy which covers COVID-19 related medical treatment with a coverage of no less than USD 100,000 or equivalent.
