

## **I-General Tourist (TR)**

While Thailand still puts in place travel restrictions, tourist who wish to travel to Thailand, can apply for the Certificate of Entry.

If you already have valid visa or re-entry permit, please apply for a COE online. Kindly visit this link <https://ottawa.thaiembassy.org/en/content/thailand-s-coe-registration-guideline-for-air-trav?cate=5f069ee272a783584326eaf5>

If your visa has expired or you do not have visa, you need to apply for a visa. Please send all required documents for a visa via postal mail or courier to the Thai Embassy in Ottawa, 180 Island Park Drive, Ottawa, ON K1Y 0A2.

### **Required documents for VISA:**

*If you are not a Canadian citizen and you are the citizen of the following countries, you need to provide 3 copies of all the required documents along with 3 copies of valid Permanent Resident Card/ Canadian Student Permit/Canadian Work Permit /Canadian visa inside your passport.*

***Please note:*** *The Embassy is only authorized to issue visas to residents of Canada, we cannot accept a visitor visa.*

## **Tourist visa (TR)**

- Original passport (no copies) with 6 months validity
- 1 visa application form filled out and signed
- 1 passport size photo (2x2 or bigger) taken within the last 6 months
- visa fee: \$50, cash - money order only in Canadian funds payable to “Royal Thai Embassy”
- A copy of round trip E-ticket confirmation / flight confirmation
- A copy of Bank statement with an equivalent of no less than 1,000 CAD)
- A copy of accommodation confirmation or invitation letter from house/condo owner that applicant will stay after quarantine
- For non-Canadian citizen, a copy of permanent resident (PR) card or a copy of work permit or a copy of study permit is required

- During the COVID\_19 situation, we accept documents by mail/courier only
- To return your documents by courier, please include a prepaid return label.
- To return your documents by Canada post, please include a prepaid express post envelope. From Ontario and Quebec’s envelopes should be “Regional”, all other provinces' envelopes should be “National”. Please fill in your address including your name, street number, street name, city, province and postal code.

**The Embassy is not responsible for envelopes returned due to incorrect addresses.**

**Please prepare documents below to apply for COE ONLINE: (All documents must be in English Only)**

1. A copy of your passport
2. A copy of your Thai visa
3. A copy of your health insurance policy with coverage including COVID-related treatment in Thailand in the amount no less than 100,000 USD for a period of at least 3-month validity from the date of departure and it should cover your period of your stay in Thailand\*
4. A copy of a hotel booking for **Alternative State Quarantine (ASQ)** at one of the hotels approved by the Thai authorities \*
5. **Declaration form**
6. A copy of e-ticket confirmation
7. For non-Canadian citizen, a copy of permanent resident (PR) card or a copy of work permit or a copy of study permit is required

**What you need to present at airlines check-in counter and immigration upon arrival in Thailand:(All documents must be in English Only)**

1. The Certificate of Entry
2. Declaration form
3. Fit to Fly health certificate, issued within 72 hours before departure
4. Medical certificate with a laboratory result indicating that COVID -19 is not detected **COVID test must be by RT-PCR method**, issued within 72 hours before departure
5. Copy of your insurance policy which covers COVID and no less than 100,000 USD for a period of at least 3-month validity from the date of departure and it should cover your stay in Thailand.
6. Copy of your confirmed booking at an ASQ hotel
7. **T.8 form**
