



Announcement by the Faculty of Economics, Kasetsart University  
Academic Excellence Scholarship for ASEAN Countries Students  
Bachelor of Economics (English Program)

---

Building an international network among Thais and citizens within Association of South East Asian Nations (ASEAN) countries becomes more important. Faculty of Economics, Kasetsart University foresees that and aims to enhance the international learning environment for the Bachelor of Economics Program (BEcon). The program wishes to increase the number of admitted international students, especially from ASEAN countries (Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore and Vietnam), to enroll the full-time degree. As part of our internationalization effort, the program announces the scholarship for students from ASEAN countries, subject to the following details:

**1. About the Scholarship**

These scholarships are to celebrate academic excellence in our international student population. The BEcon Program awards

1.1 Two full tuition fee and living-expenses scholarships for each academic year. The successful candidate will be able to waive the entire tuition fee and receive full living expenses for four-year undergraduate course.

1.2 One full tuition fee and half living-expenses scholarship for each academic year. The successful candidate will be able to waive the entire tuition fee and receive half of the living-expenses for four-year undergraduate course.

**2. Scope and Detail of the Scholarship**

**2.1 full tuition fee and living-expenses scholarship**

2.1.1 Tuition fee for four-year undergraduate course will be fully funded (no more than eight consecutive semesters)

2.1.2 The successful candidate will receive financial supports as follows

- (1) Monthly allowance worth 7,500 THB, 12 months per year
- (2) Student visa fee no more than 1,900 THB per year based on the actual cost
- (3) Health insurance fee no more than 8,500 THB per year based on the actual cost
- (4) Accommodation expenses no more than 8,000 THB, 12 months per year based on the actual cost

(5) Roundtrip economy airfare as follows:

- Flight ticket (economy class) to Thailand for the first semester of study
- Flight ticket (economy class) to the student's home country, after completing all of the degree requirements
- Flight ticket support shall be no more than 10,000 THB per flight

2.1.3 Successful candidate must consistently maintain GPAX of at least 3.50 in each semester, and all subject has never been re-registered, withdrawn or graded with F, I or N. As the candidate fails to achieve the requirements, the sponsor may terminate the scholarship at any time.

2.1.4 Successful candidate must not hold any other internal and external scholarship sources.

2.1.5 Successful candidate must be of good character and never have a record of disciplinary offenses.

2.1.6 Successful candidate must participate and assist with affair or cultural exchange activities under BEcon program as assigned such as orientation day, economic problem contest and public relation for BEcon program.

## 2.2 Full tuition fee and half living-expenses scholarship

2.2.1 Tuition fee for four-year undergraduate course will be fully funded (no more than eight consecutive semesters)

2.2.2 The successful candidate will receive financial supports as follows

- (1) Monthly allowance worth 4,000 THB, 12 months per year
- (2) Student visa fee no more than 950 THB per year based on the actual cost
- (3) Health insurance fee no more than 4,250 THB per year based on the actual cost
- (4) Accommodation expenses no more than 4,000 THB, 12 months per year based on the actual cost
- (5) Roundtrip economy airfare as follows:
  - Flight ticket (economy class) to Thailand for the first semester of study
  - Flight ticket (economy class) to the student's home country, after completing all of the degree requirements
  - Flight ticket support shall be no more than 5,000 THB per flight

2.2.3 Successful candidate must consistently maintain GPAX of at least 3.50 in each semester, and all subject has never been re-registered, withdrawn or graded with F, I or N. As the candidate fails to achieve the requirements, the sponsor may terminate the scholarship at any time.

2.2.4 Successful candidate must not hold any other internal and external scholarship sources.



2.2.5 Successful candidate must be of good character and never have a record of disciplinary offenses.

2.2.6 Successful candidate must participate and assist with affair or cultural exchange activities under BEcon program as assigned such as orientation day, economic problem contest and public relation for BEcon program.

### 3. Eligibility criteria

3.1 The applicant must hold a valid passport, issued by one of the ASEAN countries (Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore, Vietnam) and must not concurrently hold Thai citizenship.

3.2 Accept an unconditional admission offer from the BEcon program.

3.3 The admission procedure will be considered based on SAT (Math), portfolio and interview.

3.4 The applicant must not reside in Thailand at the time the application submitted.

3.5 The applicant must successfully obtain the equivalent of Grade 12 (for American high school system) or O-Level (for British high school system) follows the criteria of International Studies Center, Kasetsart University by the end of August of that academic year.

### 4. Funding source

Bachelor of Economics (BEcon program), Department of Economics, Faculty of Economics, Kasetsart University.

### 5. Required documents

5.1 Completed scholarship application form


5.2 Current 1 inch x 1 inch passport style photo

5.3 Photocopy of your passport, certified by your signature. The copy of your passport must present issuing authority, date issued, and expiration date (at least 6 months before the passport is expired)

5.4 Official transcript from educational institutions with an explanation of grading scale

The evaluation and selection process are subject to the discretion of the Operating Committee of the BEcon program. The decisions made by the committee are final.

This announcement is effective since the academic year 2022 onwards.

## Scholarship for Foreign Students

Entrepreneurial Economics Bachelor of Arts – EEBA (International Program)

Faculty of Economics, Kasetsart University

### 1. Rational Criterion

Kasetsart University Faculty of Economics is offering Entrepreneurial Economics Bachelor of Arts (International Program) as an applied economics course in order to produce entrepreneurs with academic knowledge and skills in both economics and business.

The program aims to promote human resource development, create opportunities for Thai students to study with foreign students, develop business operations skills, and build international business networks that will assist the students as they launch their careers into the future.

### 2. Objectives

To provide financial support and encourage international students to apply for full-time degree study in the Entrepreneurial Economics Bachelor of Arts (International Program), Faculty of Economics, Kasetsart University

### 3. Number and Scope of the Scholarship

- 3.1 Up to five scholarships will be awarded to entering students each year
- 3.2 Tuition for the successful candidate will be waived for no more than eight (8) semesters (4 academic years)
- 3.3 The following financial support will be provided to the successful candidate:
  - 3.3.1 Personal expenses 5,000 THB per month during their degree program studies
  - 3.3.2 Round trip economy airfare as follow:
    - Flight ticket (economy class) to Thailand for the first semester of study
    - Flight ticket (economy class) to the student's home country, after completing all of the degree requirements



- Flight ticket support shall be no more than 30,000 THB per flight for students coming from Asia and no more than 50,000 THB per flight for students coming from other regions.

3.3.3 Visa fee no more than 2,000 THB (must submit receipt)

- 3.4 Application fee and bank charge 300 THB
- 3.5 Successful candidate must participate and assist in programmatic or cultural exchange activities under Entrepreneurial Economics Bachelor of Arts (International Program) as assigned
- 3.6 Successful candidate must consistently maintain GPA of at least 2.70 in each semester

#### 4. Qualifications

Applicants must meet admission requirements stated by Kasetsart University and the Faculty of Economics (Entrepreneurial Economics Bachelor of Arts – EEBA) at the time application is submitted.

- 4.1 Applicants must have completed or currently enrolled in grade 12
- 4.2 Applicants must meet at least two of the following criteria;

	Admission requirements
1. The cumulative GPAX	≥ 2.50 out of 4.00 scale
2. English Proficiency Test: Applicant must submit at least one of following: - TOEFL (iBT)	≥ 70
- IELTS	≥ 5
3. The cumulative GPA of mathematic subjects must be	≥ 2.50 out of 4.00 scale

#### 5. Funding source

Entrepreneurial Economics Bachelor of Arts – EEBA (International Program)
