For Visa Application (STV- valid for 90 days, extendable up to 270 days)

- > Original passportwhichisvalid for at least 12 months and its copy
- Copy of BahrainResidence Permit
- Copy of Bahrain CPR
- No objection letterfrom the employer (statingnames, passportno., position and basic salary)
- > Copy of plane ticket
- Twopassport size photos
- Proof of ownership of a condominium unit in Thailand (e.g. condo unit titledeed) or a hire-purchasecontract of a condominium unit in Thailandwith at least 2 installmentspaid
- ➤ Health and accident insurance with the minimum coverage of 40,000 baht for outpatient treatment and 400,000 baht for inpatient from a Thai insurance company (which can be found on http://longstay.tgia.org/)
- For spouse or child travelling together proof of relationship (e.g. marriagecertificate, birthcertificate) and letter of guarantee

Visa fee: BHD 25.000 (Single Entry)

- 2. For Certificate of Entry (COE) Application
 - Completed Declaration Form
 - ➤ Health Insurance Policy with the coverage of medical treatment in Thailand, including COVID-19 treatment, in the minimum amount of 100,000 USD or equivalent
 - Proof of Alternative State Quarantine (ASQ) hotel booking for 14 days (if your travel date cannot be confirmed, please make a flexible booking with the hotel)

Reminder: All non-Thai nationals travelling to Thailand must have the following documents (for boarding the plane):

- Certificate of Entry
- A valid visa or re-entry permit
- Negative COVID-19 RT-PCR test result, undertaken no longer than 72 hours before the flight departure (other kinds of test are not accepted)
- Fit to Fly health certificateissued no longer than 72 hrs before the flight departure
- Confirmation of Alternative State Quarantine (ASQ) booking for 14 days
