2	Proof of financial ability demonstrating possession or availability of sufficient liquid financial resources which can be utilized during the applicant's stay in Thailand e.g recent bank statements showing at least 3 months account activities, with the relevant bank branch's contact details		
3	Original letter of guarantee from a person/entity in the Hong Kong SAR with secure financial position, stating that the person/entity agrees to be the applicant's guarantor, including as regards any and all expenses, damages, liabilities, and other costs arising in relation or incidental to the applicant's travel to or stay in Thailand, along with proof of the guarantor's financial ability/status and identity/incorporation document(s)		
4	Original letter of guarantee from a person/entity in Thailand with secure financial position, stating that the person/entity agrees to be the applicant's guarantor, including as regards any and all expenses, damages, liabilities, and other costs arising in relation or incidental to the applicant's travel to or stay in Thailand, along with proof of the guarantor's financial ability/status and identity/incorporation document(s)		
5	[For Tourist Visa and Special Tourist Visa applicants] Proof that the applicant's travel to Thailand is arranged by a tour/travel agency, with clear schedule of activities covering the entire period of stay in Thailand, along with the tour/travel agency's incorporation/establishment/registration/license document(s)
