**Note:**

- (1) Once submitted the application online, the visa fee is non-refundable.
- (2) The Embassy only has the authority to issue visas to applicants who have residency and are currently living in Morocco, Tunisia, and Mauritania. Visa applicants of those without residency and are not currently living in Morocco, Tunisia and Mauritania will be REJECTED.
- (3) The applicant's passport/travel document must have at least 6 months validity on the date of submitting the application.
- (4) The Embassy reserves the rights to request additional documents as necessary.
- (5) Please apply for your visa in advance and plan your trip accordingly. The visa approval process will take approximately 10 business days, depending on the accuracy of the application and supporting documents and the type of visa requested.
- (6) The Embassy no longer accepts walk-in to submit the visa application in person.
- (7) The Embassy has the right not to issue a visa without stating any reasons.
- (8) The Embassy has authority to issue visas to foreigners who wish to travel to Thailand. However, the authority to permit entry and stay in Thailand lies with the Thai Immigration Officer.
- (9) Please note that an applicant who applies for visa through a travel agent shall take full responsibility of his/her visa application. The Embassy advises that the applicant be selective in choosing reliable travel agency to apply for visa on his/her behalf.
