

Announcement

Non-Immigrant Business Visa (Effective from 9 October 2020)

The Royal Thai Consulate-General in Guangzhou wishes to inform the public of the resumption of issuance of Non-Immigrant Business Visa (Non-B) to Chinese and foreigners, effective from 9 October 2020. Details are as follows:

- 1. Eligibility of Applicants Chinese and foreign nationals who currently reside in Guangdong and Hainan Provinces and wish to (1) conduct business in Thailand or (2) invest in condominiums in Thailand or (3) have a Thai bank account or purchase a Thai government bond with the equivalent amount of not less than THB 3 million, can apply for this type of visa.
 - 2. Validity of Visa A Single Entry only with validity of up to 90 days

3. Required Documents for COE

- 3.1 A completed declaration form
- 3.2 A proof of payment for designated Alternative State Quarantine (ASQ) hotel of at least 14 days. For more information about ASQ, please visit http://hsscovid.com
- 3.3 A proof of Health Insurance covering all medical expenses in Thailand with a minimum coverage of USD 100,000 that includes coverage for Coronavirus Disease 2019 (COVID-19) treatment.

4. Required Documents for Visa Application

- 4.1 A passport valid for no less than 6 months
- 4.2 Fully completed and signed visa application form and its copy
- 4.3 Two copies of passport (personal information page)
- 4.4 An original bank statement of the applicant, which shows a deposit with an equivalent amount of not less than THB 500,000 for the past 6 months.
 - 4.5 Additional documents

4.5.1 For Business Trip

- (1) A letter from the dispatching company in China with a copy of identity card (ID) of signer (authorized person) and a copy of business license of the company;
- (2) A letter of invitation from the company/organization in Thailand, stating the objective and the period of the stay in Thailand; and
- (3) A copy of the registration document/business license of a company/organization in Thailand with a paid registered capital of at least THB 2 million.

4.5.2 For Property and Financial Investment in Thailand

- (1) A copy of title deed of ownership documents of the condominium owned by the applicant; OR
- (2) A proof of money transfer and a copy of complete bank statement of the applicant's account(s) in Thailand with minimum balance of THB 3 million; OR
- (3) A proof of investment in Thai government bond with a minimum purchase of THB 3 million.
- **5. Other Requirements** Upon arrival in Thailand, foreign nationals must strictly comply with disease control measures of Thai authorities, especially the 14-day quarantine, and are required to cover their related expenses.
